

An Ordinance providing for the changing of the names of certain streets in the City of Portland.

The City of Portland does ordain as follows:

Section 1: That the names of the streets within the corporate limits of the City of Portland be and the same are hereby changed as provided in Section 5 of this ordinance and the said streets shall hereafter be known by the names as provided in said section.

Section 2: All streets whose names are changed by this Ordinance are understood and declared, unless otherwise stated, to have been laid out and named while without the corporate limits of the City of Portland, and the <sup>said</sup> streets are now within the said corporate limits.

Section 3: The suffix "S.E.", meaning "Southeast", is understood to be added to and made a part of each new street and avenue name or number.

Section 4. The tabular headings in Section 5 of this ordinance are hereby made a part of and understood to fully describe and designate the name changes enumerated under them.

Section 5: That the following streets as given in the first column, located as described in the second column, shall be changed and hereafter known by the respective or corresponding names as given in the third column:
