

An Ordinance accepting permits for rights of way for the construction of the Rhine street sewer extension.

The City of Portland does ordain as follows:

Section 1. That permits for rights of way for the construction of the Rhine street sewer extension through the following tracts of land be and are hereby accepted by the City of Portland:

A strip of land fifteen (15) feet in width the center line of which is described as follows: Beginning on the east line of East Twenty-second street at a point which is intersected by the easterly extension of the center line of Frankfort street; and thence running easterly along said easterly extension of the center line of Frankfort street a distance of 650 feet, more or less, to an intersection with the northerly line of said grantor's land at a point which is 275.61 feet west of the west line of East Twenty-sixth street, when measured along the center line of Frankfort street. Given by Kate Cox, Guardian.

A strip of land fifteen (15) feet in width lying directly south of and adjacent to the southerly boundary line of Waverleigh Heights, an addition to the City of Portland, the center line of said fifteen (15) foot strip of land being described as follows: Commencing on the east line of Kenilworth avenue at a point which is 7.5 feet south of the northerly line of said grantor's land, when measured at right angles thereto; and thence running north 85°53' east and parallel to the said southerly boundary line of Waverleigh Heights, a distance of 277.49 feet, more or less, to a point on the easterly line of said grantor's land, which is 7.7 feet east of the southerly extension of the west line of East Twenty-ninth street. Given by the Cowen-Ida Company.

A strip of land fifteen (15) feet in width lying directly south of and adjacent to the southerly boundary line of Waverleigh Heights, an addition to the City of Portland, the center line of said fifteen (15) foot strip of land being described as follows: Beginning on the west line of said grantor's land at a point which is 7.7 feet east of the west line of East Twenty-ninth street, extended; and thence running south 70°41' east and 7.5 feet distant from and parallel to the said southerly boundary line of Waverleigh Heights, a distance of 131 feet, more or less, to the east line of said grantor's land. Given by Emma F. and Thomas W. Turner.

A strip of land fifteen (15) feet in width lying directly south of and adjacent to the southerly boundary line of Waverleigh Heights, an addition to the City of Portland, the center line of said fifteen (15) foot strip of land being described as follows: Beginning on the east line of said grantor's land at a point which is 7.7 feet east of the southerly extension of the west line of East Thirtieth street; and thence running north $70^{\circ}41'$ west and 7.5 feet distant from and parallel to the said southerly boundary line of Waverleigh Heights, a distance of 131 feet, more or less, to the west line of said grantor's land. Given by Ludwina and August Senti.

A strip of land fifteen (15) feet in width lying directly south of and adjacent to the southerly boundary line of Waverleigh Heights, an addition to the City of Portland, the center line of said fifteen (15) foot strip of land being described as follows: Beginning on the west line of said grantor's land at a point which is 7.7 feet east of the southerly extension of the west line of East Thirtieth street; and thence running north $65^{\circ}17'$ east and 7.5 feet distant from and parallel to the said southerly boundary line of Waverleigh Heights, a distance of 126.3 feet, more or less, to the east line of said grantor's land. Jacob and Elise Bolliger.

A strip of land fifteen (15) feet in width lying directly south of and adjacent to the southerly boundary line of Waverleigh Heights, an addition to the City of Portland, the center line of said fifteen (15) foot strip of land being described as follows: Commencing on the west line of East Thirty-second street at a point which is 7.5 feet south of an easterly extension of the northerly line of said grantor's land, when measured at right angles thereto; and thence running north $73^{\circ}36'$ west and parallel to the said southerly boundary line of Waverleigh Heights, a distance of 225 feet, more or less, to an angle point; thence south $65^{\circ}17'$ west and parallel to the said southerly boundary line of Waverleigh Heights, a distance of 205.15 feet, more or less, to a point on the west line of said grantor's land, which is 62.4 feet, more or less, east of the east line of East Thirtieth street, as laid out in said Waverleigh Heights. Given by Perry and Emma A. Tomlinson.

A strip of land fifteen (15) feet in width, lying directly south of and adjacent to the northerly boundary line of lots 1 and 19, block 2, in Cooper's Addition to East Portland, now Portland, said fifteen (15) foot strip of land extending from the east line of East Thirty-second street to the west line of East Thirty-third street. Given by Mary E. and M. J. Kelley.

A strip of land ten (10) feet in width, the center line of which is described as follows: Commencing on the easterly line of lot 3, block 1, in Linda Vista, an addition to the City of Portland, at a point 5 feet south of the northeast corner of said lot 3, and running thence westerly 5 feet distant from and parallel to the northerly line of said lot 3, a distance of 119.5 feet to a

point of curve; thence southwesterly on a curve to the left having a radius of 40 feet and tangent to the last above mentioned course a distance of 20.9 feet, more or less, to an intersection with the westerly line of lot 5, in said block 1, at a point which is 196.6 feet north of the southwest corner thereof. Given by R. S. and Rose B. Shelley.

A strip of land ten (10) feet in width, the center line of which is described as follows: Commencing on the east line of lot 1, block 1, in Linda Vista, an addition to the City of Portland, at a point 5 feet south of the northeast corner of said lot 1, and thence running westerly five (5) feet distant from and parallel to the northerly line of said lot 1, a distance of 80 feet to an intersection with the westerly line of said lot 1. Given by the Richardson Investment Company.

A strip of land ten (10) feet in width, the center line of which is described as follows: Commencing on the westerly line of lot, block or tract 6, in Klippel Acre Tracts, an addition to the City of Portland, at a point 5 feet south of the northwest corner of said block 6, and running thence easterly 5 feet distant from and parallel to the northerly line of said block 6, a distance of 76.55 feet to an intersection with the easterly line of said grantor's land. Given by Sarah M. Crosby.

A strip of land ten (10) feet in width, the center line of which is described as follows: Commencing on the north line of block or lot "L", in Richmond Addition to East Portland, now Portland, at a point 10 feet west of the northeast corner of said block "L", and thence running south 45°55' west, a distance of 360 feet, more or less, to a point on the south line of block or lot "J", in said addition, which point is 85.2 feet east of the southwest corner of said block "J". Given by L. E. and Mae Rice.

Section 2. That the Auditor be and is hereby directed to have the permits for rights of way through the tracts of land described in Section 1 of this ordinance placed on record.
