

An Ordinance accepting certain property for street purposes, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described property be and is hereby accepted by the City of Portland for street purposes:

The west ten (10) feet of Lots 1 and 2, Block 6, Summit Annex, (S. B. Martin);

The west ten (10) feet of Lots 3, 4 and 5, Block 6, Summit Annex, (S. J. Brice);

The west ten (10) feet of Lots 6 and 7, Block 6, Summit Annex, (Ida and Charles Whatley);

The west ten (10) feet of Lot 1, Block 5, Summit Annex, (R. R. Morrill);

The west ten (10) feet of Lot 2, Block 5, Summit Annex, (Rosa Joseph);

The west ten (10) feet of Lot 3, Block 5, Summit Annex, (Joe Haddad);

The west ten (10) feet of Lots 4, 5, 6, 7 and 8, Block 5, Summit Annex, (Roy R. Fields);

Also beginning on the east line of East Fifty-fifth street at a point which is intersected by the southerly line of Belmont street; and thence running southerly along the said east line of East Fifty-fifth street a distance of twenty-two and forty-five hundredths (22.45) feet to a point of curve; thence northeasterly and tangent to the last above mentioned course, along the arc of a curve to the right, having a radius of thirty-six and thirty-eight hundredths (36.38) feet and a central angle of $63^{\circ} 22'$ a distance of forty and twenty-three hundredths (40.23) feet to the point of tangency of the southerly line of Belmont street; thence southwesterly along the said southerly line of Belmont street a distance of twenty-two and forty-five hundredths (22.45) feet to an intersection with the said east line of East Fifty-fifth street and the place of beginning.

Also beginning on the southerly line of Belmont street at an angle point which is distant seventy-five and forty-nine hundredths (75.49) feet from the east line of East Fifty-Fifth street, when measured along the said southerly line of Belmont street as at present established; and thence running southwesterly along the said southerly line of Belmont street a distance of twenty-two and six-tenths (22.6) feet to a point of curve; thence easterly and tangent to the last above mentioned course along the arc of a curve to the right, having a radius of ninety-two and thirty-four hundredths (92.34) feet and a central angle of $27^{\circ} 30' 30''$, a distance of

forty-four and thirty-three hundredths (44.33) feet to the point of tangency of the south line of Belmont street; thence westerly along the said south line of Belmont street a distance of twenty-two and six-tenths (22.6) feet to the aforementioned angle point and place of beginning. (Pacific Telephone & Telegraph Company);

Section 2. That the Auditor be and is hereby directed to have the deeds to the property described in Section 1 of this ordinance placed on record; provided, however, that said deeds shall not be placed on record until all liens on account of taxes and assessments to this date have been paid.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in that the interests of the public demand the widening of East Fifty-ninth street in Summit Annex so that it may be taken over as a city street and improved and that the dangerous intersection of East Fifty-fifth street and Belmont street may be changed, therefore an emergency is hereby declared, and this ordinance shall be in force from and after its passage by the Council.
