

WHEREAS, pursuant to agreement between the city and county concerning the improvement of N. Columbia Boulevard and N. Swift Boulevard with ingress and egress related thereto, the city agreed to relinquish to the county the street areas found appropriate therefor so that the county may proceed to improve and widen the street for present and future traffic to and from commercial and industrial areas both inside and outside the city; that it is appropriate that such jurisdiction of the city be relinquished at this time in order to permit appropriate planning and construction contracts and relinquishment of said street areas and would be in the best interests of the public; now, therefore


BE IT RESOLVED by the Council of the City of Portland that the city does hereby relinquish to Multnomah County, Oregon, jurisdiction for the purpose of construction, reconstruction and maintenance of the following street areas:

- N. COLUMBIA BLVD. - From the east line of N. Albina Ave., westerly to the west line of Woolsey Court.
- N. WALKER STREET - Extended westerly from the west line of Woolsey Court, westerly to the west line of N. Portsmouth Ave., including portions of Adriatic and Hodge Avenues.
- N. WALKER STREET - From the west line of N. Portsmouth Ave., westerly to intersection with N. Columbia Blvd.
- N. COLUMBIA BLVD. - From the intersection with Walker Street, westerly to the center line of Portland Blvd. and N. Columbia Blvd.
- N. COLUMBIA BLVD. - From the center line of N. Portland Blvd. and Columbia Blvd. southwesterly to 270 feet west of N. McCrum Avenue.
- N. SWIFT BOULEVARD - From the center line of N. Portland Rd. and N. Columbia Blvd., westerly to the east line of N. Oregonian Avenue.
- N. McCRUM AVENUE - From the center line of N. Columbia Blvd. northerly to the south line of N. Swift Boulevard.
- N. DELAWARE AVE. - From the south line of N. Columbia Blvd. southerly 260 feet.

- N. ARGYLE STREET - From the west line of N. Denver Ave., westerly to the east line of N. Kenton Avenue.
- N. KENTON AVENUE - From the north line of N. Argyle Street northerly to the north line of N. Hampton Street.
- N. TYNDALL STREET - From the center line of N. Houghton St. northerly to the south line of Columbia Blvd.

AND, BE IT FURTHER RESOLVED that such relinquishment to Multnomah County, Oregon, shall be effective upon amendment by delineation of the contract between the city and county dated September 20, 1966, and upon proper acceptance of jurisdiction of the aforesaid street areas by the Board of County Commissioners of Multnomah County.
