*Amend the FY 2014-15 budget appropriation schedule in the amount of \$28,500 for the purchase of one Hybrid/Electric sedan for use by the Office of Neighborhood Involvement at \$28,500 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- The CityFleet Division of the Bureau of Internal Business Services recognizes the need to purchase one Hybrid/Electric sedan to be used by the Office of Neighborhood Involvement (ONI).
- 2. This Hybrid/Electric sedan will be used to transport personnel and supplies to be used in the Crime Prevention Program. Currently, employees are using their personal vehicles to complete their job assignments which is at higher cost to the City.
- 3. It has been determined that one sedan needs to be purchased for the Office of Neighborhood Involvement (ONI) Exhibit A attached.
- 4. The City now desires to purchase this sedan for \$28,500 funded by the Office of Neighborhood Involvement.

NOW, THEREFORE, the Council directs:

- a. The CityFleet Division of the Bureau of Internal Business Services, OMF, is hereby authorized to purchase this sedan for use by the Office of Neighborhood Involvement per the listed request identified in the attached, Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to pay for said purchase from the Office of Neighborhood Involvement budget.
- c. The FY 2014-15 Appropriation Schedule is hereby amended as indicated below to include appropriation adjustments for the Office of Neighborhood Involvement and CityFleet for the purchase of one Hybrid/Electric sedan.

Office of Neighborhood Involvement Fund – 100 Business Area – NI Bureau Program Expenses – \$0

CityFleet Fund – 702 Business Area – MF Bureau Program Expenses - \$28,500 Section 2. The Council declares that an emergency exists because delay in proceeding with the purchase would result in additional expense and unnecessarily deprive the City of the use of these vehicles at an early date; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
