

Ordinance No.

An Ordinance accepting permits for right of way for sewer construction.

The City of Portland does ordain as follows:

Section 1: That permits for right of way for the following sewers be and are hereby accepted by the City of Portland:

Sewer in private property from Roswell Street, through, under and along the following described property: A strip of land five (5) feet in width, the center line of which is described as follows: Beginning on the north line of lot four (4) block two (2) in Montgomery Park, an addition to the City of Portland, at a point two (2) feet east of the northwest corner of said lot four (4); and thence running south 20° 30' east a distance of 106 feet, more or less, to a point twelve (12) feet west of the southeast corner of said lot four (4) (A.C. Chaloupka and Frank Chaloupka)

Sewer in private property from Roswell Street, through, under and along the following described property: A strip of land five (5) feet in width the center line of which is described as follows: Beginning on the south line of lot four (4), block two (2) in Montgomery Park, an addition to the City of Portland, at a point twelve (12) feet west of the southeast corner of said lot four (4); and thence running south 20° 30' east a distance of 164 feet to a point; thence south 8° 00' east a distance of 40 feet, more or less, to the north line of Patton Road at a point five (5) feet west of the west line of Greenway, an addition to the City of Portland (Gottlieb Strohecker and Anna T. Strohecker).

Sewer in Blocks "O" and "H", Greenway, through, under and along the following described property: The north ten (10) feet of lot one (1) Block lettered "H" in Greenway, an addition to the City of Portland (as the same is described in a deed recorded February 11th, 1907, in Book 384, Page 45 in the office of the County Clerk, wherein said grantor retains a right of way over and across above described property for the purpose of laying or repairing sewer or water pipes therein). Also, the west twenty-two (22) feet of lot seven (7), Block lettered "O" in Greenway, an addition to the City of Portland (as described in a deed recorded

August 11th, 1906, in Book 366, Page 466 in the office of the County Clerk, wherein said grantor reserves a right of way across above described property for a drain pipe to Patton Road). (Dorr E. Keasey and Evalyn C. Keasey)

East 50th and East Couch Street Sewer, through, under and along the following described property: A strip of land ten (10) feet in width, the center line of which is described as follows: Beginning on the west line of block lettered "H" in Sunnyslope, an addition to the City of Portland, at a point where the same is intersected by a westerly extension of the center line of East Couch Street as established in Center Addition, and thence running easterly along said westerly extension of the center line of East Couch Street, a distance of One Hundred Sixty-three and five-tenths (163.5) feet, more or less, to an intersection with the west line of said Center Addition (Moy Back Him Company.)


Section 2. That the Auditor of the City of Portland be and is hereby authorized and directed to have the permits described in Section 1 of this ordinance placed on record.
