

An Ordinance accepting permits for right of way for sewer construction.

The City of Portland does ordain as follows:

Section 1: That permits for right of way for the following

sewers be and are hereby accepted by the City of Portland:

22nd and Myrtle Street Sewer, through under and along the following described property: A strip of land four (4) feet in width, the center line of which is described as follows: Commencing on the northwesterly line of 22nd Street at a point which is 24 feet distant, northeasterly from the northeast corner of block seventy five (75) in Carter's Addition to the City of Portland; and running thence north 63°35' west a distance of 100 feet, more or less, to the westerly line of said grantor's land; thence running south 19°00' east a distance of 30.8 feet, more or less, to an intersection with a westerly extension of the southerly line of Clifton Street at a point which is 80 feet distant northwesterly from the northeast corner of said block seventy-five (75), in Carter's Addition. Said above described strip of land being a portion of lot five (5), block sixty-five (65) in said Carter's Addition (M.H. Houser and Caroline E. Houser).

22nd and Myrtle Street sewer, through, under and along the following described property: A strip of land four (4) feet in width, the center line of which is described as follows: Commencing on the northwesterly line of 22nd Street at a point which is ninety-two (92) feet distant southwesterly from the northeast corner of block seventy-five (75) in Carter's Addition to the City of Portland; and running thence north 19°00' west a distance of 122 feet, more or less, to an intersection with a westerly extension of the southerly line of Clifton Street, at a point which is 80 feet distant north easterly from the northeast corner of said block seventy-five (75), in Carter's Addition. (Charles A. Burckhardt and Phoebe A. Burckhardt.)

22nd and Myrtle Street sewer, through, under and along the following described property: A strip of land four (4) feet in width, the center line of which is described as follows: Commencing at a point 100 feet northwesterly from the northwesterly line of 22nd Street and 23 feet north 32°00' east from the southwesterly line of Clifton Street, produced; and thence running north 60°17' west a distance of 215.2 feet, more or less, to an intersection with the westerly line of lot five (5), block sixty-five (65), in Carter's Addition to the City of Portland. Said above described strip of land being a portion of said lot five (5), block sixty-five (65) in Carter's Addition. (Walter V. Smith and Edith J. Smith).

22nd and Myrtle Street sewer, through, under and along the following described property: A strip of land four (4) feet in width, situate, lying and being in lot six (6), block sixty-five (65), Carter's Addition to the City of Portland; the center line of said strip of land being described as follows: Commencing on the easterly line of said lot six (6) at a point north 22°00' east, 48 feet from a point which is distant north 68°00' west, 312 feet from the southeast corner of block sixty-five (65) in said Carter's Addition; and running thence north 60°17' west a distance of 42.2 feet to an angle point; thence north 25°23' west a distance of 250 feet, more or less, to the southeasterly line of Canyon Road. (Jane Caples et al.)

A system of sewers in Westover Terraces, through, under and along the following described property: A strip of land five (5) feet in width, north of an adjoining the south line of lots on (1) and twenty-five (25), twenty-six (26), twenty-seven (27), twenty-eight (28) and twenty-nine (29), all in block seventeen (17), Westover Terraces, an addition to the City of Portland, being a five (5) foot strip of land extending from Ariel Terrace to the east line of lot thirty-one (31) in said block seventeen (17). (Westover Co.)

Section 2: That the Auditor of the City of Portland be and is hereby authorized and directed to have the permits described in Section 1 of this ordinance placed on record.
