

ORDINANCE No. 187 258

* Authorize six grant agreements for programming for at-risk youth in partnership with Portland Parks & Recreation Community Centers in an amount not to exceed \$320,000 (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

1. As part of the 2015-16 Budget, the Council appropriated funds for grants to organizations to provide programming for at-risk youth in partnership with PP&R's Community Centers.
2. The Mayor's Office solicited proposals from a number of organizations who provide such services.
3. The Mayor's Office has reviewed the proposals, and recommends that grants be awarded, in the form of the Agreements attached to six organizations, for an aggregate amount of \$320,000.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to execute, on behalf of the City of Portland, grant agreements with Portland Opportunities Industrialization Center (POIC), Immigrant & Refugee Community (IRCO), Latino Network, Native American Youth and Family Center (NAYA), Boys & Girls Club of Portland, and Rosewood Initiative, substantially in the forms attached to this Ordinance, and the Mayor or the Mayor's designee is authorized to take all actions on behalf of the City provided in the agreements.
- b. The Mayor and City Auditor are hereby authorized to pay for the grants from the General Fund.

Section 2. The Council declares that an emergency exists because delay in the execution of the grant agreements will unduly jeopardize the availability of programming for at-risk youth, particularly in the summer months; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
