## Ordinance No. 32921.

An Ordinance repealing certain ordinances, and declaring an energency.

The City of Portland does ordain as follows:

Section 1. REPHAL OF ORDINANCES. The following ordinances and parts of ordinances and all ordinances amendatory thereof are hereby repealed:

'Sections 6 to 45, inclusive, of Ordinance No, 15885, ontitled, "An Ordinance to define the duties of the City Physician and of the Health Officer; to protect the public health and to prevent the spread of contagious and infectious diseases." Fassed April 6, 1904.

Ordinance No. 23723, entitled, "An Ordinance prescribing certain regulations in the conduct and management of Hospitals, providing a penalty for violations thereof, and declaring an emergency." Passed July 12, 1911.

Ordinance No. 27785, entitled, "An Ordinance" prohibiting the establishment, within the limits of the City of Portland, of Sanitariums for the treatment and care of persons afflicted with tubercular diseases, and providing for the removal, within one year of all Sanitariums now established for such purposes, providing a penalty for violations thereof, and repealing all ordinances or parts of ordinances in Conflict herewith, and declaring an emergency." Passed September 19, 1915.

Ordinance No. 9188, entitled, "An Ordinance toprovide for the prevention of burials and interments within certain parts of the City of Portland, and declaring such burials and interments to be a nuisance and misdemeanor." Passed March 20, 1895.

Sections 14, 25, 26, 27 and 67 of Ordinance No. 14049, entitled, "An Ordinance concerning offenses and disorderly conduct." Passed June 15, 1904.

Ordinance No. 16238, entitled, "An Ordinance to provide for the prevention of burials and interments within 70 feet of the east line of Host 26th Street between East Stark and Belmont streets, in the City of Portland, and declaring such burials and interments to be a nuisance and misdemeanor." Passed February 20, 1907.

Ordinance No. 51848, entitled, "An Ordinance exempting veterans of the Civil War from the provision of the ordinance authorizing the Health Officer to collect a fee of fifty cents upon furnishing a certified copy of the record of any birth or death." Passed June 21, 1916.

Ordinance No. 20150, entitled, "An Ordinance prohibiting the hawking and peddling of salve, liniments, drugs or medicines on the streets of the City of Portland, and declaring an emergency." Passed October 13, 1909.

Ordinance No. 26241, entitled, "An Ordinance regulating the sale and disposal of certain drugs within the City of Portland, providing a penalty for violations thereof, and repealing part of Section 25 of Ordinance No. 14049, entitled, "An Ordinance conserning offenses and disorderly conduct", approved June 17, 1934." Passed Hovember 13, 1912.

Ordinance No. 30490, entitled, "An Ordinance regulating the scho of Camabis Indica in the City of Portland, and declaring an emergency." Passed May 26, 1915.

Ordinance No. 31605, entitled, "An Ordinance making it unlawful to have in possession certain drugs." Passed April 12, 1916.

Ordinance No. 15282, entitled, "An Ordinance to protect the public health, and prohibit the sale of unwholesome fruit and vegetables." Passed March 21, 1906.

Ordinance No. 27388, entitled. "An Ordinance to regulate the sanitary conditions within or surrounding markets, shops, creameries, grocery or provision stores, under whatever name, bakeries, confectionery stores and manufactories, restaurants, boarding houses, hotels, canneries, slaughter houses, places where oysters or other shellfish are prepared for food, and places where fowl are killed and prepared for sale or storage, repealing Ordinance No. 17198 of the City of Portland, and declaring an emergency." Passad July 25, 1913.

Ordinance No. 25831, entitled, "An Crdinance regulating the canitary conditions of any new or old buildings, street work, parks, vacant lots, docks, etc., for the prevention of using such places or any

other place for the dumping of any kind of rubbish, garbage, tin cans, old lumber, brush, etc., and for the prevention of using such places or any other place for toilet purposes to commit a nuisance by disposing of human or animal feces, and declaring an emergency." Passed August 28, 1912.

Ordinance No. 17188, entitle. "An Ordinance relating to and providing for the protection of certain buildings and food products from invasion by rate in the City of Portland, and to prevent the introduction of contagious diseases in said city, and providing penalty for violation thereof." Passed November 27, 1907.

Ordinance No. 1347, sutitled, "An Ordinance for the preservation of health and prevention of disease." Passed June 11, 1873.

Ordinance No. 25441, entitled, "An Ordinance restricting the building of barns or stables, and providing a penalty for violations thereof, and dearing an emergency." Passed May 24, 1911.

Ordinance No. £7005, entitled, "An Ordinance regulating the construction and use of buildings for stables and for the keeping of horses, mules and cattle within certain districts of the City of Portland, and providing a penalty for violation thereof." Passed May 14, 1913.

Ordinance No. 27214, entitled, "An Ordinance to amend Section 4 of Ordinance No. 27005, entitled, 'An Ordinance regulating the construction and use of buildings for stables and for the keeping of horses, mules and cattle within certain districts of the City of Portland, and providing a penalty for violations thereof', approved by the Mayor, Nay 15, 1913."
Passed June 11, 1913.

Ordinance No. 32125, entitled, "An Ordinance prohibiting the maintenance of a stable without a permit, repealing Ordinances Nos. 25-23, 28675 and 31529, and declaring an emergency." Passed September 13, 1916.

Ordinance No. 23716, entitled, "An Ordinance relating to and regulating the construction and use of buildings for stables and for the keeping of horses, cattle and other animals." Passed July 12, 1911.

Ordinance No. 24339, entitled, "An Ordinance exempting block numbered 4, Railroad Shops Addition, from the provisions of section 7 of Ordinance No. 23716," Passed November 8, 1911.

Ordinance No. 28749 entitled. "An Ordinance amending Section 6 of Ordinance No. 23716 of the city of Portland, entitled. An Ordinance relating to and regulating the construction and use of buildings for stables and for the keeping of horses. cattle and other animals, approved by the Mayor of said City July 19, 1911." Passed April 1, 1914.

Ordinance No. 16871, entitled, "An Ordinance to provide for the disposition of certain dead antemals." Passed August 14, 1907.

Ordinance No. 17195, entitled, "An Ordinance to prevent the disposition of bottles, rags, swill or other material of a similar nature at the crematory." Passed December 12, 1907.

Ordinance No. 25686, entitled, "An Ordinance providing for filling up or draining lots, blocks or parcels of land where stagnant water stands, declaring the same a nuisance, making the cost of filling up and draining such property a lien and declaring an emergency." Passed August 14, 1912.

Ordinance No. 29698, entitled, "an Ordinance regulating the cleansing, sale and use of wiping rags." Passed October 21, 1914.

Ordinance No. 14716, entitled, "An Ordinance regulating carpet cleaning and renovating establishments, and prohibiting the same in certain localities." Passed June 26, 1905.

Ordinance No. 15348, entitled, "An Ordinance prohibiting the maintenance and operation of shody factories and rag mills within the corporate limits of the City of Portland." Passed April 18, 1906.

Ordinance No. 26165, entitled, "An Ordinance requiring persons, firms or corporations owning or operating elsewaters to provide for the use of the operators of such elevators stools or seats, and providing a penalty for violation thereof." Passed October 23, 1912.

Ordinance No. 25821, entitled, "An Ordinance requiring the provision of scats for employes." Passed March 25, 1913.

Ordinance No. 29270, entitled, "An Ordinance to prohibit common drinking cups and common towels in the City of Portland, and providing a penalty for the violation thereof." Passed July 29, 1914.

Ordinance No. 27885, entitled, "An Ordinance making regulations for protection against flies in certain places, prescribing a penalty, and declaring an emergency." Passed October 8, 1913.

Section 2. EFFECT OF REPEALS. This ordinance shall not revive any ordinance which has been repealed by any of the ordinances mentioned herein, or cause the discontinuance of, or annul any proceeding pending under said ordinances, or impair any rights thereunder which may have accrued to the city of Portland.

Section 3. EMERGENCY. Inserted as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That the great number of ordinances in effect at the present time causes confusion and uncertainty as to the law of the City, therefore an emergency is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
