## ORDINANCE No. 187270

\*Authorize a contract with the lowest responsible bidder for the SE Holgate & SE Ramona: 122<sup>nd</sup> to 136<sup>th</sup> Ave Sidewalks project. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Bureau of Transportation applied for a Transportation Enhancement (TE) Grant in the amount of \$1,487,000 on September of 2010 for the SE Holgate & SE Ramona: 122<sup>nd</sup> to 136<sup>th</sup> Avenue Sidewalks project.
- 2. The City Council passed Ordinance No. 185317, dated May 16, 2012, approving the Intergovernmental Agreement (IGA) to receive the grant from Oregon Department of Transportation.
- 3. The City Council approved Amendment #1 on December 11, 2013, extending the schedule.
- 4. This project is identified in the City's Capital Improvement Program (CIP).
- 5. The Bureau's level of confidence in the cost estimate for this project is moderate as the project scope is clearly understood and well defined.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to PBOT T00305 when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because it is important to advertise this project as soon as possible to begin construction of concrete work before the winter season; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
