

Ordinance No. 34093.

An Ordinance providing for the changing of the names of certain streets, and naming a street, in the City of Portland.

The City of Portland does ordain as follows:

Section 1. That the names of the streets hereinafter mentioned, within the corporate limits of the City of Portland, be and the same are hereby changed as provided in Section 3 of this ordinance, and the said streets shall hereafter be known by the names provided for in said Section 3.

Section 2. The tabular headings in Section 3 of this ordinance are hereby made a part of and understood to fully describe and designate the name changes enumerated under them.

Section 3. That the following streets as given in the first column, located as described in the second column, shall be changed and hereafter known by the respective or corresponding names as given in the third column:

Section 4. Nothing contained in this ordinance shall in any way affect the validity of any proceedings now pending for the improvement, opening, laying out, extending or widening of any of the streets above mentioned, or for the changing or establishing of grades thereon, but such proceedings shall continue and be completed as though the names of such streets had not been changed.
