ORDINANCE No. 187308

Authorize an Intergovernmental Agreement with U.S. Department of Agriculture Forest Service Mt. Hood National Forest for mutual aid assistance (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The United States Department of Agriculture Forest Service, Mt. Hood National Forest, (US Forest Service) seeks to improve emergency response capabilities by providing for joint participation in incident management teams, cooperation in the suppression of wildland fires, and to provide assistance or conduct operations during Presidential/Stafford Act declared disasters and emergencies.
- 2. The City of Portland, through its Portland Fire & Rescue (PF&R) bureau, desires to enter into this agreement to provide and/or receive periodic emergency assistance in the suppression of wildland fires, and Presidential/Stafford Act declared disasters and emergencies.
- 3. This proposed mutual aid agreement is mutually advantageous to all parties for access to the personnel and equipment of the other parties, as needed.
- 4. This agreement allows PF&R to seek reimbursement for certain costs incurred in providing mutual aid.
- 5. The provisions of ORS 190.110(1) authorize the City to enter into this agreement with US Forest Service.
- 6. The term of this agreement is five (5) years.

NOW, THEREFORE, the Council directs:

a. The Fire Chief is authorized to execute an Intergovernmental Agreement with the US Forest Service for mutual aid assistance, substantially in accordance with the terms and conditions as shown in Exhibit A, attached hereto.
