

ORDINANCE No. 187313

Amend Intergovernmental Agreement with Oregon Department of Transportation for the Red Electric Trail Project to reflect the current project limits, schedule, and updated processes under the Local Agency Certification Program. (Ordinance; amend Contract No.30002431)

The City of Portland ordains:

Section 1. The Council finds:

1. In September 2011, City Council executed an Intergovernmental Agreement (IGA) with the Oregon Department of Transportation (ODOT) for the Red Electric Trail Project: SW 30th – SW Vermont via Ordinance No. 184888, (Grant TR000183).
2. This IGA amendment serves to update the specified project limits for the Red Electric Trail Project as well as revise the project schedule, ODOT reporting requirements, and ODOT personnel estimate and contact information.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge is hereby authorized to amend an Intergovernmental Agreement with Oregon Department of Transportation for the Red Electric Trail Project, in a form similar to the contract attached as Exhibit A.
- b. The Commissioner-in-Charge is authorized to execute amendments, approved as to form by the City Attorney, to the scope of the services or the terms and conditions of this Agreement, provided the changes do not increase the City's financial risk. Increases to the grant amount must be approved by the City Council.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Commissioner-in-Charge's behalf.
