Redevelopment of the ADA Title II Transition Plan for the City of Portland

Pursuant to Ordinance Number 186061, 186631, and _____

This Contract was made and entered into on May 14th, 2012 by and between MOORE IACOFANO GOLTSMAN, Inc (MIG), hereinafter called Contractor, and the City of Portland, a municipal corporation of the State of Oregon, by and through its duly authorized representatives, hereinafter called City.

1. Additional work is required to perform ADA Title II inspection services on the Keller Auditorium, Arlene Schnitzer Concert Hall, and Antoinette Hatfield Hall including the Newmark, Winningstad and Brunish Theaters. Though not included in the facility list covered by the original contract, these facilities are owned by the City and operated by Portland's Centers for the Arts under direction by the Metropolitan Exposition and Recreation Commission. As the owner of the facilities, the City has an obligation to include them in its ADA Title II Transition Plan. This work will include preparing facility diagrams, conducting facility surveys, preparing facility reports, prioritization of barriers in consultation with City and Portland's staff, preparation of a barrier analysis tool for ongoing use, and project management.
2. Additional compensation is necessary to complete the above work and shall not exceed \$29,215, for a new not to exceed amount of \$670,773.
3. This contract is amended to extend the termination date from December 31, 2015 to June 30, 2016 to allow for completion of the above described work.
4. The City's project manager for the work covered by this amendment will be Karl Lisle, Spectator Facilities and Development Coordinator with the Office of Management and Finance, and all consultant task coordination, progress reports, invoices and products should be addressed to him. For all other tasks, both those in the original contract and those covered under other amendments, the project manager will continue to be Danielle Brooks, ADA Program Manager with the Office of Equity and Human Rights.

All other terms and conditions shall remain unchanged and in full force and effect.
