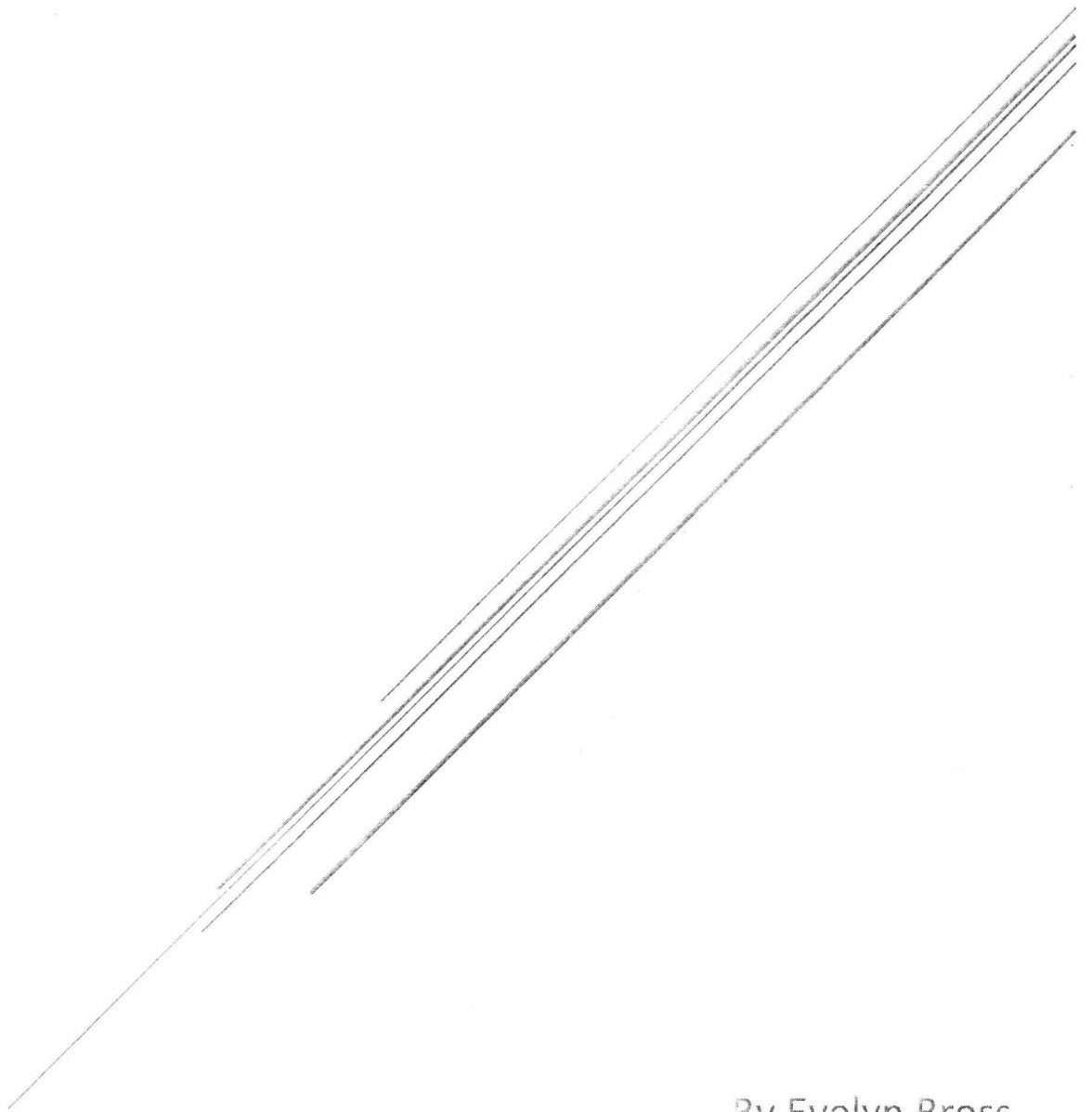

Driving to Enter the Post Office on Airport Way



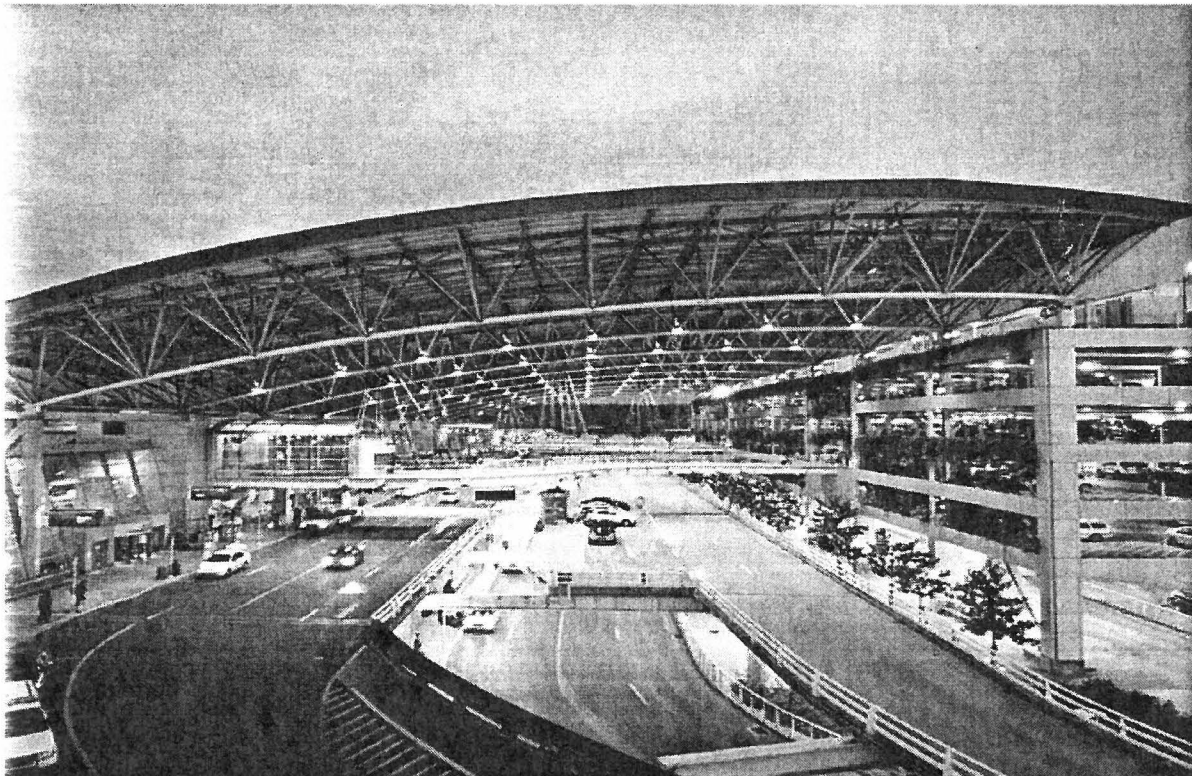
