

ORDINANCE No. 187324

*Pay claim of Norman Bailey in the sum of \$11,000 involving Portland Parks and Recreation.
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Norman Bailey has filed a bodily injury claim against the City for damages suffered in an injury accident involving the Portland Parks and recreation on March 25, 2014.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the claim be compromised for the total sum of \$11,000.00, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:


- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$6,000.00 made payable to Norman Bailey. A previous payment has been sent to his auto insurer for \$5,000 as reimbursement of all medical payments and liens.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
