## AMENDMENT No. 3 GRANT AGREEMENT NO. 32000404

OREGON ("CITY" OR "GRANTOR"	'and Legal Aid Services of Oregon	("LASO" OR
"GRANTEE") is effective as of	, 2015.	

## **RECITALS:**

- 1. On March 13<sup>th</sup>, 2008 the City of Portland, Oregon, accepted the recommendations of the Feasibility Study for a One Stop Domestic Violence Center and subsequently opened the Gateway Center for Domestic Violence Services ("the Gateway Center") based on the recommendations therein. The study gauged a high-level of interest and support among service providers, and a strong need for such a center among victims and survivors of domestic violence.
- 2. The feasibility study recommended that civil legal assistance be among the core services offered at the Gateway Center.
- 3. Legal Aid Services of Oregon (LASO) was recommended by the Center's advisory council to provide the onsite civil legal assistance because of LASO's experience providing legal aid to domestic violence victims specifically and LASO's participation on collaborative partnerships for vulnerable populations in general.
- 4. On or around July 1, 2010, the City of Portland entered into a Grant Agreement No. 32000404 with LASO to provide civil legal assistance at the Gateway Center.
- 5. Since the Gateway Center opened in September 2010 it has been visited by thousands of survivors of domestic violence and their children.
- 6. The original grant term was set to conclude on June 30, 2013. Amendment No. 1 extended the grant until June 30, 2014.
- 7. Amendment No. 2 extended the term of the grant until June 30, 2016.
- 8. Civil legal assistance has been and continues to be one of the highest sought after services at the Center. Further, other community resources in this service area have been reduced.
- 9. Due to overwhelming need for civil legal assistance for domestic violence survivors served at the Gateway Center for Domestic Violence Services, the City has budgeted \$120,000 annually for this service.

Therefore, Parties agree as follows:

## ACTIONS TO BE TAKEN BY GRANTEE

- 1. The Recitals above are true and correct and are part of this Amendment No. 3.
- 2. The Grant Agreement term shall extend three years and shall terminate on June 30, 2018, unless otherwise sooner terminated under any provisions of the Grant Agreement.
- 3. The total grant funds shall be increased by \$360,000 to reflect the extended terms as indicated in the above recitals.
- 4. Except as modified in this Amendment No. 3, the terms and conditions of the Grant Agreement shall remain in full force and effect.

The Parties have executed this Amendment No. 3 to Grant Agreement 32000404 in duplicate on the day and year written, and the corporate signature of Grantee being by authority of the Board of Directors of the executing corporation.
