

ORDINANCE NO.

(IMPROVEMENT)

An ordinance declaring the cost of improving **as a district, portions of East Broadway, Williams Avenue, Benton Street, Multnomah Street, Ross Street, Cherry Street, Weidler Street, Larrabee Street, Wheeler Street, Dixon Street, Clackamas Street, Halsey Street, Wheeler Street from Weidler Street to Clackamas Street, Vancouver Avenue and Ross Street,**

and assessing the property benefited thereby, declaring such assessment and directing the entry of the same in the Docket of City Liens.

THE CITY OF PORTLAND DOES ORDAIN AS FOLLOWS:

Section 1. That the Council has considered the proposed assessment for improving **as a district,**

East Broadway, from the west line of Benton street to the center line of Union avenue;

Williams avenue, from the center line of Holladay avenue to the south line of East Broadway;

Benton street, from the west line of Williams avenue to the southeasterly line of Clackamas street;

Multnomah street, from the east line of Williams avenue to the center line of East 1st street;

Ross street, from the northwesterly line of Halsey street to the north line of Multnomah street;

Cherry street, from the east line of Vancouver avenue to the south line of Weidler street;

Weidler street, from the southeasterly line of East Broadway to the west line of Williams avenue;

Larrabee street, from the southerly line of Dixon street to the west line of Delay street;

Wheeler street, from the northerly line of East Broadway produced northeasterly to the north line of Hancock street;

Dixon street, from the westerly line of Wheeler street to the center line of Ross street;

Clackamas street, from the southwesterly line of Benton street to the northeasterly line of Wheeler street;

Halsey street, from the northeasterly line of Ross street to the southwesterly line of Williams court;

Wheeler street, from the south line of Weidler street to the northwesterly line of Clackamas street;

Vancouver avenue, from the southerly line of Cherry street to the south line of Weidler street; and

Ross street, from southeasterly line of East Broadway to 30 feet southerly therefrom;

and all objections made thereto, and hereby ascertains, determines and declares the whole cost of said improvement in the manner provided by Ordinance No. **55065** to be the sum of \$ **102,952.46** and that the special and peculiar benefits accruing to each lot, or part thereof or parcel of land within the assessment district, by reason of said improvement and in just proportion to such benefits, are in the respective amounts set opposite the number or description of each lot, or part thereof, or parcel of land in the annexed assessment roll, and said assessment roll, which is numbered **5650**, is hereby adopted and approved as the assessment for said improvement, and the Auditor of the City of Portland is directed to enter a statement of the assessment hereby made in the Docket of City Liens, and cause notice thereof to be published as provided by Charter.
