

ORDINANCE No. 187339

Amend the City Code to reflect the name change of the Revenue Bureau. (Ordinance; amend Code Chapters 5.73, 6.04, 6.05, 6.06, 7.02, 7.03 and 7.14)

The City of Portland ordains

Section 1. The Council finds:

1. Effective July 1, 2015, the Revenue Bureau was merged into the Bureau of Revenue and Financial Services.
2. As a result, the name of the Revenue Bureau was changed to the Revenue Division of the Bureau of Revenue and Financial Services.
3. Chapter 5.73 (Arts Education and Access Income Tax), 6.04 (Transient Lodgings Tax), 6.05 (Tourism Improvement District), 6.06 (District Property Management License), 7.02 (Business License Law), 7.03 (Temporary Businesses) and 7.14 (Utility License Law) are administered by the Revenue Division. These chapters still contain references to the Revenue Bureau. In order for the City Code to reflect the current name of the administrator, amendments to Code Chapters 5.73, 6.04, 6.05, 6.06, 7.02, 7.03 and 7.14 are needed.
4. In the Business License Law, there is also the need to correct a reference to Oregon law and to clarify the language for a specific exemption.


NOW, THEREFORE, the Council directs:

- c. City Code Chapter 6.05 is amended as set forth in the attached EXHIBIT C.
- d. City Code Chapter 6.06 is amended as set forth in the attached EXHIBIT D.
- e. City Code Chapter 7.02 is amended as set forth in the attached EXHIBIT E.
- f. City Code Chapter 7.03 is amended as set forth in the attached EXHIBIT F.
- g. City Code Chapter 7.14 is amended as set forth in the attached EXHIBIT G.
