* Revise ordinance for amendments to Intergovernmental Agreements with TriMet and 14 participant agencies to correct term date from September 30, 2015 to September 28, 2015 (Ordinance; amend Ordinance No. 187221)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 187221 passed Council on June 24, 2015 authorizing amendments Intergovernmental Agreements with TriMet and 14 participant agencies to provide police transit services.
- 2. The ordinance passed, but included an error in the term expiration date. The date listed in the ordinance was September 30, 2015. The correct date is September 28, 2015.
- 3. The corrected ordinance title should read as follows: * Amend Intergovernmental Agreements with TriMet and 14 participant agencies to extend the term to September 28, 2015 to provide police transit services (Ordinance; amend Contract No. 30001665, 30001544, 30001908, 30001378, 30001379, 30001545, 30002000, 30001625, 30001380, 30001546, 30001381, 30001382, 30001384, 30001385, 30001386)
- 4. It is in the interest of the City, TriMet and 14 participant agencies that the City revise Ordinance No. 187221 without delay to allow each the mutual benefit that it will confer.

NOW THEREFORE, The Council directs:

a. The Ordinance No. 187221, title is amended to read as follows:

* Amend Intergovernmental Agreements with TriMet and 14 participant agencies to extend the term to September 28, 2015 to provide police transit services (Ordinance; amend Contract No. 30001665, 30001544, 30001908, 30001378, 30001379, 30001545, 30002000, 30001625, 30001380, 30001546, 30001381, 30001382, 30001384, 30001385, 30001386)

b. All other terms and provisions of Ordinance No. 187221 remain the same and are not affected by this amendment.

Section 2. The Council declares that an emergency exists because a delay in renewing the one Prime and 14 Participant Agency Intergovernmental Agreements would disrupt the continued mutual benefit transit policing services provide to the City, TriMet and the public. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


