## Ordinance No. 550446

An ordinance transferring title to Lots 6,7, 8 and 9 and parts of Lots 5 and 14 Water Bureau Addition to the City of Portland, Oregon, from the Bureau of Water Works to the Fire Bureau and transferring Lots 12, 13 and the South 1/2 of Lot 14, Block 29, Sunnyside, Lot 14. Block 29, Albina Homestead and the Merth 1/2 of the East 1/2 of Lot 6, Block 47, Holladay Addition, excepting therefrom the Eastern ten feet taken for street widening, from the Fire Bureau to the Bureau of Water Works and declaring an emergency.

Whereas, the Fire Bure u desires to use Lots 6,7.
8 and 9 and parts of Lots 5 and 14, said fractional lots
being more fully described as follows: Fractional Lot 5:
Beginning at the Northeast corner of Lot 5: thence S. 16°
24° 15" W. 123.29 ft; thence N. 0° 13° 45" W. 139.75 ft; thence
S. 58° 43° 46" E. 41.39 ft. to the place of beginning. Also
that portion of Lot 14 described as: Beginning at the Northeast corner of Lot 14; thence S. 16° 24° 15" W. L distance of

thence S. 73° 35° 45" E. a distance of 26.19 ft. to the
place of beginning, all in Water Bureau Addition, City of
Portland, Oregon, and

Whereas, said Fire Bureau is willing to transfer to the Bureau of Water Works at an even trade Lots 12, 13 and S 1/2 of Lot 14. Block 29, Sunnyside; Lot 14. Block 29, Albina Homestead; and the North 1/2 of the East 1/2 of Lot 6, Block 47, Holladay Addition, excepting therefrom the Easterly ten feet taken for street widening, and

Whereas, the Commissioner of Public Affairs in charge of the Fire Bureau and the Commissioner of Public Utilities in charge of the Bureau of Water Works are agreeable to such even trade, therefor

THE CITY OF PORTLAND DOES ORDAIN AS FOLLOWS:

Section 1. That the above described parcels of land be and the same are hereby transferred in the manner mentioned above am the City Auditor, the Fire Bureau and the Bureau of water works are hereby authorized to change their records accordingly.

Section 2. Imagement as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Fortland in this: The Fire Bureau is anxious to take over immediately for training quarters the property described in Water Works Addition, therefore an emergency is hereby declared to exist and this ordinance shall be in force and effect from and After its passage by the Council.
