



Governor's office releases 94,000 Cylvia Hayes emails

Update on April 4 at 10:22 a.m.: Access the files holding Cylvia Hayes emails.

A public release of about 94,000 email files Friday provides the most sweeping view yet of Cylvia Hayes' deep role in state government during the administration of former Gov. John Kitzhaber.

The record, dating to the start of Kitzhaber's third term in 2011, was disclosed by Gov. Kate Brown's office.

So far the key takeaways include:

• More insight into what former Gov. John Kitzhaber knew -- and when -- about Hayes' deep involvement within his administration and across state government since early in his third term.

• Further examples of how Hayes directed state employees and to some extent, Kitzhaber's policies, further contradicting her attorneys' arguments that she was not a public official.

Hayes acknowledged her "confusing" dual roles in late 2012, months before she accepted three other paid consulting jobs.

A team of reporters from The Oregonian/OregonLive is examining the archive, and their findings will be frequently added to this post. The emails include all traffic from three private email accounts used by Hayes and any staffer in the governor's office. They do not include direct communications with Kitzhaber, who conducted his state business on personal email accounts not yet released.

Kitzhaber and Hayes are the targets of a sweeping federal criminal investigation into influence peddling.

Kristen Grainger, spokeswoman for Gov. Kate Brown, wrote in an email that some of the documents released today were labeled "internal advisory" and might normally be exempted.

However, she wrote, "Governor Brown believes that, in view of the unique and historic circumstances surrounding these particular documents, the strong weight of the public interest justifies the release of these records."

Smaller sets of emails released in the past have raised questions about Hayes' practice of accepting paid consulting contracts that centered on the very work products and policy issues for which she was advising the governor - and for which he was pushing through in his platform.

Emails we add will be time-stamped and included below as they come in.

Updated 7:22 p.m.

The flow of emails will stop for the evening, but we will continue to analyze and post results in coming days.

Updated 6:49 p.m.

Hayes describes her work as a fellow for the Clean Economy Development Center in a Dec. 9, 2011 email. She wrote the fellowship included speaking engagements in Oregon and that she had relationships "with governors and spouses." She earned \$118,000 for the fellowship. The center's director has said Hayes' work -- and the center's -- were not focused on Oregon.

This is my first ever ask out of the Governor's Strategic Reserve fund during my 3-year tenure. While I strongly support prospective changes to the strategic funding process, keeping up the momentum on the ground-breaking regional PCC effort is at a critical juncture.

I hereby request \$100,000 to support our implementation work under the 3-Governor accord signed in October 2013.

After two years where PCC implementation work has been heavily supported by over \$600,000 in foundation support, jurisdictions now must begin funding a greater share.

As you know, I have put PCC "dues" in the 2015-2017 request, but Washington and California have recently come forward with 100k each to fill in the implementation shortfall for 2014-2015 which has already benefitted our work on 111d, clean fuels, resilient infrastructure and more (see attached PCC document).

So I am hoping we can execute an agreement similar to what Washington has done with California which is managing the effort.

Please see email string below for specifics, but the bottom line is the Rental Gallery has billed us \$2,808 for six months for the paintings you have selected (excluding one painting) and we were all under the impression they were being loaned. I'll get back to you when I hear back from Jennifer again. So sorry for this potential disruption.

When we moved to Mahonia Hall, there was no art over the big living room fireplace and there were two giant mirrors over the side tables in that room. There was no art in the front hall or the stairwell, and only two pieces in the little living room. I did not like this absence of art.

asked the then-director of the museum, John Buchanan, whether Mahonia Hall could be loaned some art and he agreed. I got this idea from Margie Goldschmidt, former first lady. The deal that I struck with Mr. Buchanan--a "gentleman's agreement" with no paper trail--was that the museum would loan the pieces free of charge. In return, the docents and I would be sure to tell the guests that the pieces were generously loaned from the Portland Art Museum.

Mr. Buchanan assigned a curator to me; I think her name was Margaret and I think she is no longer with the museum because of down-sizing. Margaret made one visit to Mahonia Hall to measure the size of the spaces and to look at the general decor of the house. Margaret and I then chose pieces appropriate for Mahonia Hall from the collection in the museum vault. During that visit to the museum vault, Mr. Buchanan ran into me in the hall and insisted that I also take the Bierstadt piece that had been hanging in his office (which was very kind of him). Margaret, counseled me to choose about 15 pieces because surely the museum would not approve some of the pieces. This counsel turned out to be wise; a couple of pieces needed attention (to the art or the frames), one was scheduled for an exhibit at the museum within the next year, etc.

Someone from DAS and Ed Geisbrecht then worked with the museum to cover, respectively, insurance issues and hanging issues (i.e., making holes in the walls). I recall that the museum covered the insurance angle so that the state was not paying money for this loan of art. This aspect was very important to me because we were all trying NOT to spend state funds.

With Margaret's help, I created a "cheat sheet" for the docents to use in giving tours so that they could explain not only the source of the art but also the individual artists. When I lived at Mahonia Hall, I know that the docents used the cheat sheet routinely (thus holding up our end of the gentleman's agreement).

At least once someone from the Gov's office contacted me to say that the museum had reminded us that it was time to renew the loan and inquired whether I was still happy with the art or wished to choose other pieces, and I just stuck with what I had chosen initially.

Once, someone told me that the Overbeck piece (yellow roses) was in Mahonia Hall when Gov. Roberts lived there. This person--I can't recall who it was--said that the museum's loaning art for Mahonia Hall was a long tradition, and remarked how coincidental it was that Gov. Roberts and I both liked that Overbeck painting.

That's everything I know!

Collahoratives, Coordinated Care Organization, Early Learning Hubs or Achievement Compacts with 197 school districts. The list goes on. How many times have these folks asked for meetings with me to xpress their concerns? And have I ever said "no, I will not meet with you?" How many times, for example, has the Wild Salmon Center been in my conference room? Every time Guido has asked to meet with me I have made it happen. At his request I carved out time to give a speech at the Eco-Trust Building on creating a Conservation Fund.

So, no apology needed from you Tom. You are doing a great job. But this is a BIG deal between me personally and the conservation community. And, in a way, it makes my life a whole lot easier and a whole lot simpler. While I remain fully committed to long term sustainable environmental stewardship worrying about what these particular groups think and want and worry about just dropped a few rungs on my priority list.

For Cylvia Hayes: ?Oregon has publicly talked about its preference for a carbon tax rather than a cap-and-trade program so you don?t seem to be contemplating the kind of linked market approach that California and Quebec has or that exists among the RGGI states. Usually new taxes are anathema to politicians so why does Oregon prefer a tax-based approach??

Other Possible Questions:

- Oregon is probably a lot more similar to Quebec than it is California at least in terms of its emissions profile since both are largely hydroelectric energy dominated leaving most emissions to come from the transportation sector. Can you achieve your desired emission reductions in that sector though zero emission vehicle and low carbon fuel programs without relying on pricing carbon?

- Is the alignment of climate policies in a collaborative scheme desirable and does the reliance on a carbon tax complicate such efforts at alignment if they are both focused on an emissions trading scheme?

- Taxes are notorious for their special exemptions and carve outs. How do you prevent tax lobbyists from creating loopholes or otherwise undermining your tax program so that it both equitable and that it achieves your emission reduction goals?

Hello, Cylvia:

I am writing to you today to request your assistance in addressing an ongoing issue with regard to small hydro development in Central Oregon. North Unit Irrigation District (NUID), in partnership with small hydro developers, has identified multiple locations within its canal system that provide the opportunity for small hydro development. As part of the hydro development process, a secondary use water right must be issued by the Oregon Water Resource Department (OWRD) for hydro use. Through the water right process the Oregon Department of Fish and Wildlife (ODFW) has input and discretion with regard to requiring fish screening and passage - or not ? hence the matter before us with regard to fish screening.

In 2010, as Central Oregon Irrigation District (COID) and Swalley Irrigation District (SID) were preparing to begin construction on hydro projects in their canals, ODFW required that fish passage be implemented at North Canal Diversion Dam before ODFW would sign off on the project ? essentially holding the projects. In the end an agreement was reached by ODFW, COID, SID and NUID by which funding would be garnered over the next several years to construct a fish passage facility. The passage project is estimated to cost \$1.5 million. The agreement requires a 60% ODFW/40% districts cost share for which the districts have been diligent about collecting. Fast forward to April 2013, again ODFW has stepped forward to require screening at NUID?s diversion even though screening currently exists ? just not to ODFW latest standards.

On April 18, 2013, NUID met with ODFW Director Roy Elicker and staff to discuss the screening matter. In short Mr. Elicker directed the district to put its concerns in writing (see attached) to ODFW so that ODFW had a clear understanding of the districts position. ODFW committed to a quick turnaround response (7 days) given the nature of the issue and stage of development of the hydro projects ? as of today we have no response from ODFW nor do they have the courtesy to return numerous calls to further engage in this matter.

I would very much like to discuss this matter with you in more detail as this issue has the potential to derail 6 hydro projects (5 in NUID and 1 in COID) that are in different phases of development. Not only will these projects suffer but the jobs created from these projects will be lost, revenues allowing further investment in the district will be lost, the loss of renewable energy and associated benefits will be lost, and finally those interested in developing hydro power in Oregon will take their business elsewhere due to the burdens the state places on these projects.

Thank you for your time and consideration with regard to this matter.

That being said, I have a few concerns that I want to get on the table.

1. Common Message

Because Cylvia has not been well integrated into the Administration over the past three years, the considerable effort she has put into poverty/prosperity in her capacity as First Lady has been largely parallel and not convergent with the rest of the work we have been doing.

Therefore, it is of great importance that we develop a common message and way to talk about the Prosperity Initiative and to take advantage of the additional capacity that Cylvia brings by coordinating and leveraging her work in alignment with our common goals.

It is important to define what we mean by the First Lady "leading the Prosperity Initiative."

It is important that the work Cylvia does on the Prosperity Initiative (and the remarkable following she has created) is coordinated and aligned with the overall administration. That is, she needs to be engaged in strategic planning and long term scheduling; she needs communication support for her public appearances; and the groups she is convening, her efforts to secure grant funding, etc. need to be part of our overall strategic plan.

It is important that the goals of the Prosperity Initiative are not seen as separate and different from the goals of the Administration or of the Oregon Business Plan (which I view as part of our outside implementation strategy). If we are not careful and intentional, people could easily see the goals of the Prosperity Plan and the goals of the Oregon Business Plan as two separate, duplicative and unrelated efforts. And there is a lot of overlap here.

15 Goals of the Prosperity Plan: (1) reducing poverty from 17.5% to below 10% by 2020 and below 5% by 2025; (2) raising income levels to above the national average by 2020; (3) significant reduction of income inequality by 2025.

Goals of the Oregon Business Plan: (1) creating 20,000 jobs per year each year until 2020; (2) raising income levels to above the national average by 2020; (3)

reducing poverty from its current level of 17.5% to below 10% by 2020

We currently have an Oregon Prosperity Initiative website that was created some time ago when Cylvia was leading what amounted to an almost parallel effort. It is important as we go forward that this is aligned and integrated with the rest of the work we are doing. That is, it is important that the first thing people see when they open the home page of the Oregon Prosperity Initiative is a clear and compelling narrative that captures both what we are doing to better serve those already living in poverty; and what we are doing to prevent poverty by addressing its root cause.

The latter goal - to address the root causes of poverty - encompasses much of the work we are doing in education (including early learning), workforce and health care. Therefore, we need to be able to link in to these efforts and to see them as all supporting the objectives of the Prosperity Initiative. Right now I think the website is pretty weak.

I also think that we need to make sure there is alignment and synergy between our State website, my website, the First Lady's website and the Prosperity Initiative website. This is way beyond my pay grade (websites and all things electronic and virtual) but if the Prosperity Initiative is going be the way we capture all the work we are doing into a single narrative then we need to redesign that site and make sure it is connected to other sites where people can get updates on our suite of major policy initiatives (the action plans to achieve our common goal). I'm willing to take a different direction on this one. I think this is a red herring and does nothing except boost fundraising opportunity for the environmental groups. And, indeed, the Port of Portland told us this week that there is no jurisdiction nor do they intend to have jurisdiction invoked by putting infrastructure through the Port.

Here's the deal: coal will go to China, coal will go to India. The price points (even with worldwide regulation that would significantly change the pricing) are such that American coal will roll out to the world. So I guess we could win a hollow moral victory in saying that we (Oregon and Washington) are not complicit in the worldwide coal conspiracy, but even that modicum of smugness won't hold if we go to the higher level of generality of considering ourselves Americans. And, of course, we are just as much a part of the conspiracy as anybody else, we just happen to be lucky that we had massive public investment in dams that kill fish.

As an aside, I have mentioned this to the political director at Climate Solutions after he gave a ridiculously simplistic (I might even say intellectually insulting) presentation on the subject at their dinner (and impugned the patriotism of several upper Midwest Democrats with incorrect evidence). For what it is worth, they need an upward adjustment in IQs in that department.

Here's my pitch: what we ought to do is have OSU develop some kickass carbon mitigation equipment and infrastructure for coal-fired plants, have Oregon Ironworks fabricate it, and ship it to the hundreds of Chinese and Indian coal plants when we get (or before we get) a carbon reduction treaty with teeth. The shipping has as much immediate regional impact as shipping anything to India and China, and last time I checked, one of the best possible things we could do other than reducing our debt -- and linked to that too -- is cut into our trade deficit with those countries. The global impact will remain unchanged as, again, they are going to burn that dirty garbage no matter what. Their bad corporate behavior is definitely in play to whack them with if they get some sort of Oregon hook, but otherwise this is, in my opinion, a huge waste of time and totally distracts from the real environmental issues we have here that will have very little oxygen in this atmosphere. These issues need real attention as the bad guys are going to use the economy to rape and pillage all sorts of progress.
