

ORDINANCE No.

187364

*Authorize a grant agreement with Oregon Tradeswomen, Inc. to support the Workforce Training and Hiring efforts on the Beech and Gateway Parks projects for a not to exceed grant amount of \$10,000. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

1. Oregon Tradeswomen, Inc. (OTI) is dedicated to promoting success for women in the trades through education, leadership and mentorship. It was founded on the principles that women deserve and can attain economic self-sufficiency through pursuing careers in the building, mechanical, electrical, and utility trades while helping and encouraging the trades industry build up a diverse workforce.
2. By partnering with Constructing Hope and Human Solutions, OTI is able to provide young men, women and homeless and low-income family members the skills necessary to begin careers in trade apprenticeship, thereby building pathways out of poverty and to that of self-sufficient members of the community
3. Both OTI and Constructing Hope are BOLI state-certified pre-apprenticeship programs that involve classroom training, basic hands-on construction skills, green building awareness, fitness training, OSHA instruction, construction and career work including life skills and career planning. With Human Solutions' strong presence in the East Portland community and through existing networks, the partnership seeks to connect diverse women and men of color and low-income individuals with contractors and sub-contractors.
4. The City of Portland, Procurement Services Division collects funds through its compliance-related activities to provide grant opportunities to organizations that provide recruitment and training for women, minority and student pre-apprentices to enter the construction trades. Pre-apprenticeship training slots will be first sourced to East Portland residents including those referred by Human Solutions.
5. The City's commitment to the Beech and Gateway Parks Community Benefits Plans (CBP) is reflected by its setting aside direct funding for training, outreach and construction support for the Beech and Gateway Parks projects. In accordance with the CBP for each of the projects, the funding amounts must focus on workforce training and hiring with .75% of the funds being spent for the construction of the Beech and Gateway Parks going to the surrounding community in which the Park is being built.
6. Procurement Services will add these funds to those from Portland Parks and Recreation in order to aid outreach and recruitment efforts in the areas of workforce training and hiring.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to execute a Grant Agreement with Oregon Tradeswomen, Inc. subject to approval as to form by the City Attorney's office at a cost not to exceed \$10,000.


