ORDINANCE NO. 187365

Amend Intergovernmental Agreement with Multnomah County for additional County funds in the amount of \$272,233 for outreach and housing placement for veterans and people experiencing homelessness in East County (Ordinance; amend Contract No. 30002899)

The City of Portland ordains:

SECTION 1. The Council finds:

- 1. Ordinances No. 185864, 186369, 186499 and 186925 authorized prior amendments to an authorized Intergovernmental Agreement (IGA) No. 30002899 between the Multnomah County Department of County Human Services (County) and the City of Portland, Portland Housing Bureau (City) to provide a total of \$497,357 in County general funds for flexible outreach and housing placement to veterans and people experiencing homelessness in incorporated and unincorporated areas of Multnomah County east of the Portland city limits (East County).
- 2. The County has initiated an additional amendment (Exhibit A) to the existing IGA to add \$272,233 in County general funds and to extend the scope and duration of the IGA for an additional year to the close of FY 2015-16.
- 3. The above stated services meet the goals and objectives of the City.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are authorized to execute Amendment No. 5 to the Intergovernmental Agreement between the City and the County, attached as Exhibit A.
- b. The Mayor is hereby authorized to accept on behalf of the City payments of up to \$769,590 from the County as specified in the amended IGA.
- c. The Portland Housing Bureau is authorized to perform all administrative matters in relation to the IGA, requests for reimbursement from the County, and to submit required reporting on the Mayor's behalf.
