

ORDINANCE NO. 187381

*Authorize subrecipient contract with Urban League of Portland for \$391,000 for housing placement services (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

1. The Portland City Council made a new investment of City General Funds during the 2015-16 budget process to increase access to housing for priority populations identified in *A Home for Everyone: A United Community Plan to End Homelessness in Multnomah County*.
2. The City of Portland, acting through its Portland Housing Bureau (PHB) has been a major funder of the key strategies and services of *A Home for Everyone*.
3. PHB and Urban League of Portland now desire to enter into a Subrecipient contract in the sum of \$391,000, for outreach/engagement and housing placement activities for people experiencing homelessness.

NOW THEREFORE, the Council directs that:


- a. The Bureau Director is hereby authorized to enter into a contract with Urban League of Portland in a form similar to the contract attached as Exhibit A.
- b. The Bureau Director is authorized to approve funding amendments up to 25% of the original budget amount.
- c. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Portland Housing Bureau's operating fund budget when demand is presented and approved by the proper authority.

Section 2. The Council declares that an emergency exists because delay in executing the contract could prevent currently homeless individuals from being housed. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.



