## ORDINANCE No. 187382

\* Authorize grant agreement with Self Enhancement Inc. for programming for at-risk youth in partnership with Portland Parks & Recreation Community Centers in an amount not to exceed \$50,000 (Ordinance)

The City of Portland ordains:

#### Section 1. The Council finds:

- 1. As part of the 2015-16 Budget, the Council appropriated funds for a grants that provide programming for at-risk youth in partnership with PP&R's Community Centers.
- 2. The Mayor's Office solicited proposals from a number of organizations who provide such services.
- 3. The Mayor's Office had reviewed the proposals, and recommended that six grants be awarded in the amount of \$320,000.
- 4. An additional grant was submitted and the Mayor's Office reviewed the proposal, and recommends that a grant be awarded to SEI, in the form of the agreement attached (Exhibit A), for an the amount of \$50,000.

#### NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to execute, on behalf of the City of Portland, grant agreements with Self Enhancement Inc., substantially in the form attached to this Ordinance, and the Mayor or the Mayor's designee is authorized to take all actions on behalf of the City provided in the agreements.
- b. The Mayor and City Auditor are hereby authorized to pay for the grants from the General Fund.

Section 2. The Council declares that an emergency exists because delay in the execution of the grant agreement will unduly jeopardize the availability of programming for at-risk youth, particularly in the winter months; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
