

## ORDINANCE No. 187387

\* Accept a grant in the amount of \$92,143, appropriate \$29,445 for FY 2015-16, and authorize an Intergovernmental Agreement with Multnomah County for the Domestic Violence Enhanced Response Team to be partially reimbursed for a Police Bureau sergeant through December 31, 2017 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Multnomah County Family Violence Coordinating Council partners applied to the Department of Justice (DOJ) Office on Violence Against Women (OVW) Grants to Encourage Arrest Policies and Enforcement of Protection Orders (GTEAP) program for a grant in the amount of \$649,997 for the Domestic Violence Enhanced Response Team (DVERT) program;
2. Multnomah County Department of County Human Services (MCDCHS) has notified the City that it will award \$92,143 to the City for the Police Bureau DVERT program;
3. The purpose of Intergovernmental Agreement (IGA) MC #44-1525 is to provide funds to the City and obligate agency roles and responsibilities;
4. The IGA stipulates Multnomah County will reimburse the City for 25 percent of the payroll expenses for the Police Bureau DVERT Sergeant through December 31, 2017;
5. Terms of this IGA shall begin once authorized by Council and extend through December 31, 2017, unless earlier terminated in accordance with the IGA; and
6. Council declares an emergency exists because a delay would jeopardize Fiscal Year 2015-16 grant reimbursements.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from MCDCHS for the OVW FY14 GTEAP program in the amount of \$92,143 and to execute the grant agreement.
- b. The FY 2015-16 budget is hereby amended as follows:

GRANTS FUND

Fund - 217

Business Area – PL

Bureau Program Expenses - \$29,445

- c. The Office of Management & Finance Grants Division is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City any subsequent modifications by MCDCHS for the OVW FY14 GTEAP DVERT grant, #2014-WE-AX-0043, provided such modifications do not increase the City's financial obligation or risk. Any modifications that increase the City's financial obligation or risk must be authorized by Council.

Section 2. The Council declares an emergency exists because a delay would jeopardize Fiscal Year 2015-16 grant reimbursements. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.

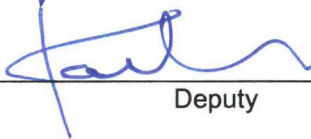
