The Division Midway Alliance for Community Improvement (DMA) is writing to urge the Portland City Council to approve the proposed Division Midway Neighborhood Street Plan that is before you. This plan was a cooperative product of Portland Bureau of Transportation (PBOT) and local community members who are acutely aware of the current conditions facing Division Midway. As a representative on the Project Working Group, DMA is proud to have worked diligently with PBOT staff and community volunteers to draft the Division Midway Neighborhood Street Plan believes implementing this plan will address necessary connectivity issues and definitely improve the lives of both the residents and businesses in Division Midway area.

As one of Portland's six Neighborhood Prosperity Initiatives (NPI's), DMA is tasked with improving the economic viability of businesses and residents living in and around SE Division Street between 117th and 148th Avenues. DMA is excited to advocate for the Division Midway Neighborhood Street Plan because the plan addresses many of the issues core to DMA's mission, including fostering public safety, improving the public image and infusing vitality into district businesses.

The committee was challenged with the fact that the as-built environment in the Division Midway neighborhoods makes connectivity more difficult than other portions of Portland. It recommends this plan as the best connectivity plan given that the area's current street layout does not make it easy for residents to access local businesses and services. The plan is beneficial for all modes of transportation but especially beneficial to pedestrians and cyclists who currently navigate long, indirect routes to access transit and local businesses – routes that currently lack sidewalks and drainage, as well as adequate lighting. By adding the necessary infrastructure to bring connectivity to this area of East Portland, Division Midway residents will benefit from increased public safety as well as an improved public image. The benefit will be most felt by the large percentage of elderly, disabled, and parents with children who rely on walking as their form of transit in this area.

The Division Midway Neighborhood Street Plan will not only improve the livability of the residents surrounding Division Street in East Portland it will also serve as a net positive for local businesses. Once this plan is implemented, residents who currently walk to the closest transit stop to access shopping outside the area will be afforded more accessibility to district businesses with safe and accessible routes to those businesses.

DMA would like to thank City Council for understanding the need to improve connectivity in East Portland by adopting the Division Midway Neighborhood Street Plan.
