Subject: Appointments to River Community Advisory Committee (RCAC)

The River Community Advisory Committee is a citizen advisory body, composed of six members who represent a variety of floating structures interests. Members are appointed by the Commissioner-in-charge of BDS and confirmed by the City Council for three-year terms and will serve no more than two complete three-year terms specified in Portland City Code Title 28. The River Community Advisory Committee members and alternates terms have expired with the exception of George Fetzer, whose 1st term expires May 21, 2016. I am recommending the following candidates for appointment to fill two of the vacancies for 3-year terms:

Outreach

The bureau recently completed a targeted outreach effort to potentially qualified members in our community. We received two interest forms from persons seeking to fill positions on the Floating Structures Board of Appeal. BDS Inspection Services Manager Mitch Nickolds reviewed the qualifications of the candidates interested and the River Community Advisory Committee requirements.

With these proposed appointments, the RCAC has four remaining vacancies. The bureau will continue its outreach efforts to fill the remaining vacancies.
