

A major transportation project has been included in the Transportation System Plan under the Project Name – **NE 148 Avenue Safety Improvements** – I am advocating that a portion of this project be started as soon as possible so that safety can be much improved insofar as 'line of sight' for traffic, just north of I-84. The Project Number is 50009.

What is required is special **grading** of a dangerous slope on NE 148th Avenue where development is expected to occur in a very short time. The special grading required is approximately 300 feet in length so that a clear line of vision is established as cars and other traffic move onto NE 148 Avenue. The closest intersection is NE 148 Avenue Place. Sidewalks on either side will add considerably to pedestrian safety.

In other words, a portion of this project must be allowed to move forward so that traffic turning in from and coming from the address at - - 3001 NE 148 Avenue - - can safely navigate onto NE 148th Avenue.
