

# ORDINANCE No. 187399

\*Pay claim of Leah Razo in the sum of \$34,456 involving Bureau of Transportation.  
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Leah Razo, through her attorney Josephine Townsend, has filed a bodily injury lawsuit against the City for injuries suffered in an automobile collision on February 22, 2012 involving the Bureau of Transportation.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the lawsuit at this time.
3. Risk Management Services recommends the lawsuit be compromised for the total sum of \$34,456.41, consisting of the following payments:

Townsend Law Trust Account:	\$23,000.00
Progressive Insurance Co.:	\$11,456.41

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver two checks, made payable as follows:


Townsend Law Trust Account:	\$23,000.00

- b. Risk Management Services will execute payment authorizations in the amounts set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this lawsuit; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.


