

ORDINANCE No. 187400

*Authorize acquisition of one full-sized sedan for use by Portland Police Bureau. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau has been offered a full-sized sedan through the Judicial Forfeiture process at no cost to the City, Exhibit A attached.
2. The CityFleet Division of the Bureau of Internal Business Services recognizes the need to add one full-sized sedan to be used by the Portland Police Drug and Vice Division for surveillance and undercover operations. The identity of this vehicle has not been compromised which adds value to its usefulness on the streets.
3. The City now desires to acquire this vehicle.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to acquire this vehicle through the Judicial Forfeiture process.

Section 2. The Council declares that an emergency exists because delay in proceeding with the acquisition would unnecessarily deprive the City of the use of this vehicle at an early date; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
