ORDINANCE No. 187408

*Amend contract with TriMet related to the operations and maintenance of the Portland Streetcar system to add payment to TriMet for Operations, Maintenance, and Other Services for FY 15/16 through FY 19/20 for \$40,490,618 (Ordinance; amend Contract No. 30002872)

The City of Portland ordains:

Section 1. The Council finds:

- On July 25, 2012, by Ordinance No. 185526, Council authorized an Intergovernmental Agreement (IGA) with TriMet related to operations and maintenance of the Portland Streetcar system.
- 2. This IGA addresses both the funding provided for Streetcar from TriMet, as an integral part of Portland's regional transit system, as well as personnel and other services provided to Streetcar for which TriMet is reimbursed by the City.
- 3. The City and TriMet annually amend this Master Agreement specifically to outline the monthly payments from TriMet to the City for Streetcar operations.
- For FY 15/16, funding from TriMet will be \$7,271,090 based upon a 73.33% funding share for the NS Line, a 50% funding share for the CL Line, and TriMet Fare revenue applicable to Streetcar.
- 5. The proposed Amendment No. 5 provides estimated City payments to TriMet for Streetcar Operations, Maintenance, and Other Services in conformance with this IGA for Fiscal Years 15/16 through 19/20.

NOW, THEREFORE, the Council directs:

That the Commissioner-in-Charge is authorized to execute Amendment No. 5 with TriMet a. related to the operations and maintenance of the Portland Streetcar system, in a form similar to the contract amendment attached as Exhibit A, as approved by the City Attorney.

Section 2. The Council declares that an emergency exists because a delay in execution could delay payment of TriMet operations, maintenance, and other services expenses; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
