

ORDINANCE No. 187429

Authorize contract with the lowest responsive bidder for the construction remodel of the Schmeer Pump Station Upgrade Project No. E07448 for \$1,800,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) needs to remodel the existing Schmeer Pump Station. Remodel is necessary due to equipment condition and age; to address safety, reliability, maintenance, and access issues; and to comply with current regulatory requirements.
2. The estimated construction cost is \$1,800,000. The level of confidence is high. Funds are available in the Sewer System Operating Fund, FY2015-2016 Budget, Bureau of Environmental Services, WBS E07448.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge is authorized to execute a contract for the purpose described in Section 1, with the lowest responsive bidder, in the amount of \$1,800,000.
- b. The Mayor and City Auditor are hereby authorized to pay for the contract from the Sewer System Operating Fund Budget.


