Purpose of proposed legislation and background information: The State of Oregon, Oregon Military Department, Office of Emergency Management (OEM) has notified the City that it will award a subgrant for the FY 2015 State Homeland Security Grant Program to the Police Bureau in the amount of \$138,112. This legislation authorizes the Mayor to accept the grant on behalf of the City. The grant period is October 1, 2015, through September 30, 2016.

Financial and budgetary impacts:

OEM will reimburse the City for program expenses not to exceed \$138,112 for training and purchase of equipment specific to explosive device remediation coverage for the Bureau's Explosive Disposal Unit (EDU).

The grant does not reimburse for overtime or backfill overtime. There may be personnel expenses related to the trainings, which will be provided by funds from FY 2015-16 Bureau budget appropriations. No match is required for this grant.

Community impacts and community involvement:

There are no legal or controversial issues. There is no voluntary citizen participation. There are no links to current City policies. The training enhances statewide response, as bomb technicians learn the latest and most effective techniques for explosive device remediation. The project also uniformly equips the state's six FBI certified explosive response teams so that resources are equally available across the state. This project directly supports the state investment area of CBRNE Detection/Response and National Priorities for Law Enforcement Terrorism prevention under the Federal priorities.
