Purpose of proposed legislation and background information:

Authorize the Chief Procurement Officer to execute a construction contract for the Inverness 30inch Force Main Repair project to Titan Utilities, LLC. The construction cost based on bids received is \$592,460.

The Inverness Force Main conveys flows from the Inverness Wastewater Pump Station located east of I-205 to the Columbia Boulevard Wastewater Treatment Plant (CBWTP), a distance of 10 miles. A single 36-inch force main bifurcates into 20-inch and 30-inch force mains for the final two miles; the force mains are supported by Columbia Slough Pedestrian Bridge where they enter the CBWTP. Corrosion in the downstream portion of the 30-inch pipe on the Bridge resulted in a leak into the Columbia Slough in 2014. Flows were transferred to the 20-inch pipe while design efforts for repairs proceeded on an expedited schedule. This project will slipline the 30-inch force main with a 24-inch HDPE pipe that connects to existing pipe at both ends of the Bridge.

Ordinance No. 187300 was approved by City Council on August 19, 2015 authorizing the Chief Procurement Officer to issue a competitive solicitation for the Inverness 30-inch Force Main Repair project on behalf of BES.

No revenues will be impacted by this legislation.

This legislation does not change existing City policy.

Financial and budgetary impacts:

Based on bids received, BES anticipates the construction contract cost to be \$592,460. The engineer's estimate for this project was \$582,000 and the confidence level was High.

Funds are available in BES's Owner Cost Center E10629.

No present positions will be created, eliminated or re-classified as a result of this legislation.

Community impacts and community involvement:

The construction contracting community, including contractors certified with the State of Oregon as minority, women, and emerging small businesses became involved when the Chief Procurement Officer advertised and publically noticed the project on the City's Online Procurement System on August 24, 2015.

Potential bidders were able to review the competitive solicitation, attend a pre-bid meeting, ask questions, provide comments and submit a bid in response to the Invitation to Bid (ITB). Bids received resulted in the award of the construction contract. Procurement Services managed the procurement process. No protests were received.

No future public involvement is anticipated or necessary for this request.
