

ORDINANCE No. 187 465

*Pay claim of Grant M. Farr in the sum of \$16,941 involving the Bureau of Transportation.
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. State Farm insurance has filed a claim on behalf of their insured Grant M. Farr for property damage to his vehicle resulting from a collision with a streetcar on June 4, 2015.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the claim be compromised for the total sum of \$16,941.08, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$16,941.08 made payable to State Farm Mutual Automobile Insurance Company.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

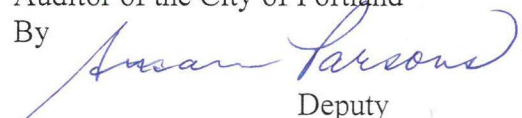
