The City of Portland ordains:

## Section 1. The Council finds:

- State Farm insurance has filed a claim on behalf of their insured Grant M. Farr 1. for property damage to his vehicle resulting from a collision with a streetcar on June 4, 2015.
- 2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
- Risk Management Services recommends the claim be compromised for the 3. total sum of \$16,941.08, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

- Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
