

ORDINANCE NO. 187496

Authorize a competitive solicitation process and contract for the purchase of aggregate services at an estimated cost of \$10,000,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Water Bureau is routinely involved in excavation work for scheduled, routine, and emergency projects to maintain the City's infrastructure. Construction standards require that the bureau backfill these excavations with approved aggregate materials as well as remove and dispose of the original excavated material (construction spoils).
2. In the past five years the Water Bureau has expended approximately \$4,000,000 on aggregate services. The bureau is projecting to continue its strong pace of system maintenance work in the next five years.
3. The Bureau of Transportation and Portland Parks and Recreation also plan to participate in this procurement solicitation. Combined those bureaus have expended nearly \$3,000,000 in aggregate services over the last five years.
4. The City currently has contracts that are near expiration and now desires to conduct a new competitive solicitation to procure aggregate services.
5. The on-going purchase of aggregate services through a competitive solicitation best serves the interests of the City, taking into account price as well as considerations including, but not limited to, experience, expertise, product functionality, suitability for a particular purpose and contractor responsibility under ORS 279B and PCC 5.33.
6. The competitive solicitation process will also ensure the safety of the public by knowing that the construction jobs are using the correct materials to backfill when needed and that the spoils are dumped in an environment that is safe for the public.
7. The estimated cost for the purchase of aggregate services over a period of five years for the City is approximately \$10,000,000.
8. The Water Bureau, on behalf of the City of Portland, seeks Council's authorization for Procurement Services to issue a competitive solicitation for aggregate services.
9. With the expected rise in aggregate usage over the next five years, the confidence level rating for this legislation is moderate. The confidence level is based on current City projects that have been forecasted, current procurement climate, and product cost.

NOW, THEREFORE, the Council directs:


- a. The Chief Procurement Officer is hereby authorized to issue a competitive solicitation in accordance with City Code for the purchase of aggregate services for an estimated amount of \$10,000,000 for a five year period once the action has passed the second Council reading.
- b. Upon Council acceptance of the Chief Procurement Officer's Report, Procurement Services is authorized to negotiate and execute a contract with the selected offeror, provided the contract has been approved as to form by the City Attorney's Office.
- c. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the appropriate authorization and accounting center when demand is presented and approved by the proper authorities.
