

Ordinance No. 74202

An Ordinance creating a Defense Services Salaries Appropriation, making a transfer, authorizing the drawing of warrants, approving certain charges against such appropriation, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. The Council finds that under the provisions of Ordinance No. 74013, passed by the Council July 10, 1940, provision is made that the difference between defense service pay and city pay for employes of the city who are called into military or civilian National Defense Service shall be paid by the city for a period of not more than three months, and the Council further finds that the accounting services in the office of the City Auditor will be simplified by the creation of a separate appropriation against which such payments shall be charged, and that such handling of such payments by the city will prevent complication in personal service appropriations of the several departments; now, therefore, a new appropriation, to be known as the "Defense Services Salaries" is hereby created (Code No. 3875.150), and a transfer of \$2000.00 is hereby authorized and directed from the appropriation account (Code No. 4100) Emergency and Unforeseen Expenditures, to the appropriation account by this ordinance created.

Section 2. The Mayor and Auditor are hereby authorized and directed to draw and deliver warrants in such sums as may be determined, due and payable to employes of the city on leave of absence under the terms and conditions of Ordinance No. 74013, such warrants to be charged against the appropriation created by this ordinance.

The payments heretofore authorized by ordinance adopted by the Council under the authority of Ordinance No. 74013 and granting leaves of absence to various city employes for defense service, and providing further that such difference in pay between their pay in such defense service and their pay by the city shall be charged to Personal Service in the various departments, shall in each instance be charged against and

payable from the appropriation created by this ordinance, instead of being charged against and payable from Personal Service Appropriations of the several departments.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland, in this: It is necessary in order that proper accounting practices may be followed that a separate account be set up for the payment of money on leave, under the provisions of Ordinance No. 74013, therefore an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
