

RESOLUTION No. **37171**

Revise the resolution approving and terminating limited tax exemptions for properties under the Homebuyer Opportunity and Multiple-Unit Limited Tax Exemption Programs to correct Exhibit A (Resolution; amend Resolution No. 37152)

WHEREAS, Council adopted Resolution No. 37152 on September 16, 2015 approving and terminating limited tax exemptions for properties under the Homebuyer Opportunity and Multiple-Unit Limited Tax Exemption Programs; and

WHEREAS, current program administrative rules have been amended to allow the tax exemption to continue on bank-owned properties purchased within 180 days of foreclosure, allowing additional families to benefit from affordable homeownership opportunities; and

WHEREAS, Resolution 37152 included Exhibit A which listed specific addresses to be approved or terminated and included a property that should not have the exemption removed at this time.

NOW, THEREFORE, BE IT RESOLVED, that Resolution No. 37152 is amended to include the corrected version of Exhibit A, as attached to this Resolution.


BE IT FUTHER RESOLVED, that all other terms and provisions of Resolution No. 37152 remain the same and are not affected by this amendment.
