Mayor Hales and Members of the City Council:

My name is Andrea Zekis and I am the Policy Director for Basic Rights Oregon. Basic Rights Oregon is the statewide advocacy organization for the lesbian, gay, bisexual, transgender and allied communities. We represent tens of thousands of Oregonians from every corner of this state.

Basic Rights Oregon supports the resolution to inventory, re-sign and plan for possible updates to ensure access to gender-neutral bathrooms within City of Portland facilities.

And we want to acknowledge Commissioner Fish and his staff for their leadership on this resolution.

Creating safe, accessible and affirming bathrooms for all people is an important policy goal that will improve the lives of Portlanders. This resolution is particularly important for Oregon's transgender communities. Transgender and gender non-conforming individuals are far more likely to experience violence and harassment.

Regrettably, a good bit of this harassment and violence occurs when transgender people visit public restrooms creating anxiety for me personally and for many others in our community. As a result of anxiety associated with activities of daily living—things other people take for granted—more than 40 percent of transgender Oregonians will attempt suicide because of this discrimination and lack of acceptance. Many people are not familiar with the transgender community and that can create fear and un-due discrimination.

Transgender people visit a public restroom for the same reasons as everyone else—to use it. And when we do, we want privacy, dignity and respect just like everyone else. We can enhance safety and acceptance by creating spaces where all of us, regardless of identity, our abilities, the assistance we need, or our age are supported and accepted.

Basic Rights Oregon strongly encourages the council to pass this resolution to create gender-neutral bathrooms.

Mayor and Council Members,

My name is Emily Pittman Newberry, and I am a transgender woman and resident of Portland, Oregon. I am also a member of the Advisory Council of SAGE Metro Portland. I write in support of the resolution you are considering on December 17, 2015 regarding gender neutral bathroom facilities at City Hall.

I was born transgender in 1944, a time when it was very dangerous to come out. I lived in hiding until I was 61 years old. All my life I was very uncomfortable using the men's bathrooms, something I had no choice about. Today as an out transgender woman I can use the women's room I where I knew I belonged. I would not wish that lifetime of discomfort on anyone.

There are transgender people who do not fit in the gender binary as I do, and being forced to choose between men's and women's bathrooms can be very stressful for them. Many have expressed to me the wish that there were more gender neutral bathrooms for them to use. At times they experience other people's uncomfortable looks or negative comments and even harassment. With gender neutral bathrooms available they and can use the facilities with the peace of mind we all expect.
