ORDINANCE NO. 187501

Authorize a contract with Toole Design Group, LLC for planning, technical and community engagement services for the Off-road Cycling Master Plan for a total not-to-exceed amount of \$199,845. (Ordinance; Contract No. 30004882)

The City of Portland ordains:

Section 1. The Council finds:

- On May 6, 2015, the City Council passed Ordinance 187114 which funded the Bureau of Planning and Sustainability and Portland Parks & Recreation to develop an Off-road Cycling Master Plan. The Off-road Cycling Master Plan will provide a citywide plan for the identification, development and management of off-road cycling trails and facilities.
- 2. The services provided by the Toole Design Group, LLC will include system planning, technical analysis, community engagement and facilitation to support development of the Off-road Cycling Master Plan.
- 3. The services were advertised under RFP 118428 and three (3) responsive proposals were received. The selection committee reviewed and scored these proposals in accordance with PCC 5.68 and selected Toole Design Group, LLC.
- 4. The City desires to enter into a PTE contract with Toole Design Group, LLC with a not-to-exceed contract amount of \$199,845.
- 5. The M/W/ESB participation in this contract is 83%.
- 6. Sufficient funding resides in BPS cost object PNCP000001 beginning in FY 2015-2016.


NOW THEREFORE, the Council Directs:
