

**ORDINANCE No. 187507**

\* Authorize special appropriation grant agreement with Oregon Symphony to provide the Symphony in the Park Program in an amount not to exceed \$190,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Oregon Symphony's mission is consistent with Council desires to provide art and culture programs to the public.
2. As part of the 2015-16 Budget, the Council appropriated one time funds for a special appropriation grant to Oregon Symphony to provide their annual Symphony in the Park Program.
3. The City's **Comprehensive Financial Management Policies**, FIN 2.04 – Budget, states that grants should be issued after a competitive application process, unless Council waives the policy in the grant ordinance. Since the Symphony in the Park is a unique annual program to the Oregon Symphony, provided free of charge for the community, a competitive application process was not implemented for this grant.

NOW, THEREFORE, The Council Directs:


- a. The Mayor is authorized to execute, on behalf of the City of Portland, special appropriation grant agreement with Oregon Symphony, substantially in the form attached to this Ordinance, and the Mayor or the Mayor's designee is authorized to take all action on behalf of the City provided in the agreement.
- b. The City Council waives the competitive application process required in FIN 2.04 – Budget.
- c. The Mayor and the Auditor are hereby authorized to provide payment as provided under the special appropriation grant agreement, chargeable to the applicable budgets when demand is presented and approved by the appropriate authorities.

Section 2. The Council declares that an emergency exists in order to avoid further delay in the provision of the special appropriation grant agreement; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
