ORDINANCÉ No. 187524

*Pay claim of Maya Kleber Rose in the sum of \$28,262 involving the Bureau of Development Services. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Maya Kleber Rose has filed a bodily injury claim against the City for damages suffered in a vehicle collision involving and employee of the Bureau of Development Services Bureau on January 8, 2014.
- 2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
- 3. Risk Management Services recommends the claim be compromised for the total sum of \$28,262.04, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver two checks in the following amounts:
 - 1) one check in the amount of \$28,000 made payable to Maya Kleber Rose and Lawrence and Ruff LLC, and
 - 2) one check in the amount of \$262.04 made payable to CareOregon Ms. Kleber-Rose's insurer.
- b. Risk Management Services will execute a payment authorization in the amounts set forth in sub-paragraph (a) above.
- Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
