

ORDINANCE NO. 78535

An Ordinance amending section 20-5503 of the license and business code (Ordinance No. 76398) so as to provide certain additional requirements for persons conducting a massage institute or giving massage treatments.

The City of Portland does ordain as follows:

Section 1. It appearing to the Council that better means should be provided for enabling municipal officers to ascertain whether applicants for operating a massage institute or operating as masseurs or masseuses are law abiding and not likely to violate the ordinance provisions of this city or communicate a disease of any kind; now, therefore, section 20-5503 of the license and business code (Ordinance No. 76398) is hereby amended to read as follows:

Section 20-5503. APPLICATION. Upon issuing a provisional license the inspector shall obtain from the bureau of police the record, if any, of the applicant, cause a written verification to be made of the references submitted by the applicant, and an examination to be made by the bureau of health of the premises where the business is to be conducted. No such license shall become final if the record shows any offense within a year prior to the date of the application, indicating moral delinquency or turpitude, or if the references fail to indicate good moral character, or if the premises and equipment fail to comply with the city ordinances or with state or federal requirements concerning health and sanitation.

Each person who has heretofore obtained a license to conduct a massage institute or to operate as a masseur or masseuse shall if he or she intends to continue to act under such license obtain on or before July 1st, 1943, from the bureau of police an identification card showing his or her signature, photograph and finger print, and the date on which such photograph and finger print were made, and present such card to the bureau of licenses. Each person who hereafter seeks to obtain a license for such activity shall obtain from the bureau of police a similar card and present the same to the bureau of licenses with his or her application.

No license shall be issued to any person who is under 21 years of age, or who cannot present five commendatory references including one from a person licensed by a state authority, or who has not been

a resident of the city of Portland for a period of at least one year immediately preceding his application for license, or who cannot present a health certificate from the bureau of health of the city of Portland, or whose premises do not comply with the requirements of city ordinances, state and federal laws, or who has within one year been convicted of a crime involving moral turpitude.
