Accept the 2015 Management Plan for River View Natural Area as a guide for future protection and use of the natural area (Resolution)

WHEREAS River View Natural Area was acquired by City of Portland for a natural area and Metro holds a conservation easement for the site; and

WHEREAS the natural area is located in the Collins View Neighborhood, between SW Palatine Road, State Highway 43 (Macadam Avenue), Lewis & Clark College, and River View Cemetery; and

WHEREAS the 146-acre natural area provides significant natural resource functions such as clean, cool water to the Willamette River and Interior Forest Habitat for wildlife; and

WHEREAS the site also provides nature based recreation for the adjacent neighbors, birdwatchers and other users; and

WHEREAS the River View Natural Area Management Plan was prepared with an advisory committee comprising representatives from the neighborhood, a mountain biker, Collins View Neighborhood Association, Lewis & Clark College, Northwest Trail Alliance, Willamette Riverkeepers, Portland Parks Board, Audubon Society of Portland, Confederated Tribes of the Grande Ronde, Southwest Watershed Resource Center, and Tryon Creek Watershed Council; and

WHEREAS there were two public open houses, two public comment periods, meetings with the interested parties including the Collins View Neighborhood Association, and stakeholder interviews to gather public input during the project.

NOW, THEREFORE, BE IT RESOLVED that The City Council of the City of Portland, a municipal corporation of the State of Oregon, affirms its acceptance of the 2015 management plan for River View Natural Area as the city's guide to the future protection, enhancement of natural resources and compatible recreation at the site.

BE IT FURTHER RESOLVED that City Council will make a final decision about whether mountain biking will be an allowed use in River View after the off road cycling master plan process is complete.
