ORDINANCE No. 187543

Authorize an Intergovernmental Agreement with law enforcement agencies for the use of the Police Bureau Training Complex (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Police Bureau grants permits to outside law enforcement agencies to train at the Portland Police Bureau's Training Complex located at 14912 NE Airport Way in Portland.
- 2. The terms of the permit are outlined in the intergovernmental agreement (IGA) template attached as Exhibit A.
- 3. The IGA template Attachment B is a Fee Schedule for the property which will aid in the Police Bureau's cost recovery for the program and ensure that the City's commitment is cost neutral.
- 4. Once the bureau begins using the IGA template, there may be many agreements that need to be reviewed and compared to the training schedule for Portland Police personnel.
- 5. Because of the volume of agreements and familiarity with Training Division resources required to approve the agreements, the Police Bureau feels that it is more efficient to have the agreements authorized by the Training Division Captain.
- 6. The Police Bureau requests that Council delegate authority to execute law enforcement training agreements to the Captain of the Training Division in order to reduce unnecessary administrative burdens on the City.

NOW, THEREFORE, the Council directs:

- The Captain of the Training Division is authorized to execute and amend a. intergovernmental agreements with law enforcement agencies in a form similar to the contract attached as Exhibit A for the use of the Portland Police Training Complex that do not obligate city funds. Portland City Council must authorize amendments to agreements that would create financial obligations on the City's behalf.
- All law enforcement training agreements authorized by this ordinance are subject to b. approval as to form by the City Attorney's Office.


