## TO THE COUNCIL:

On September 16, 2015, Council approved Ordinance Number 187345 for Procurement Services to competitively solicit the SE Powell Reconstruction and Green Streets project in accordance with PCC 5.34. The Chief Procurement Officer has advertised and received bids for Bid Number 00000160 on behalf of the Bureau of Environmental Services (BES) with a project construction estimate of \$3,730,000. BES rated the project estimate confidence level as High.

Bids were opened on December 1, 2015, and six (6) bids were received. The low bid from Landis and Landis Construction, LLC was responsive to the solicitation requirements, thus it is recommended that Landis and Landis Construction, LLC bid be accepted at the estimated unit prices as quoted for a total bid amount of \$3,535,958.50.

BES along with Procurement Services, identified an aspirational goal for D/M/W/ESB subcontractor and supplier utilization at 20% of the hard construction costs for the project. The Divisions of Work identified by Landis and Landis Construction as being performed by D/M/W/ESB subcontractors for this project are:

In their bid, Landis and Landis Construction, LLC indicated their intent to self-perform the following Divisions of Work:

Excavation 91244	Clearing & Grubbing 91219	Hauling 96239
Sewer, Water, Storm D	Site Clean Up 90976	

There is \$734,500.00 (20%) D/M/W/ESB participation on this project as follows:

- DBE \$406,500 performing Flagging & Traffic Control, Manhole Rehab, Signs, and Trucking Rock.
- MBE \$198,000 performing Boring and Jacking, and Concrete Cutting.
- ESB \$130,000 performing Trucking Rock.

Landis and Landis Construction, LLC is located in Portland, Oregon, and is not a State Certified M/W/ESB Contractor. They have a current City of Portland Business Tax Registration and EEO Certification, and are in Full Compliance with the Equal Benefits Program.

Funds are available for this project under Owner Cost Center E08659.C60.

It is recommended that a Performance Bond and Payment Bond each at 100% of the contract amount be furnished by the Contractor. Further, it is also recommended that a two (2) year Maintenance/Warranty Bond for 20% of the final contract amount be furnished by the Contractor before final payment is released.

The bid sureties of the remaining bidders should be returned immediately in compliance with Section 5.34.410D of the City Code.
