ORDINANCE No. 187563

*Authorize settlement between Oregon AFSCME, Local 189, and the City of Portland through its Portland Police Bureau regarding employment claims (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Police Bureau (PPB) terminated employee Shelley Maier on July 18, 2014. Oregon AFSCME, Local 189 ("AFSCME") grieved the termination. The City denied the grievance and AFSCME advanced the grievance to arbitration.
- 2. The parties now desire to compromise and settle the grievance. A copy of the proposed settlement is attached to this ordinance as Exhibit "A."
- 3. As part of the proposed settlement of the grievance, the City shall pay Shelley Maier an amount equal to six (6) months' back pay at her rate of pay in effect at the time of her termination in the gross amount of \$24,221.60 less all applicable withholdings and deductions.
- 4. The City and AFSCME shall equally split the arbitrator's cancellation fee.
- 5. AFSCME withdraws the grievance with prejudice.
- 6. PPB and the City Attorney's Office recommend acceptance of the proposed settlement.
- 7. Per PCC 3.15.050, the Director of the Bureau of Human Resources has reviewed and approved the proposed settlement.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a payroll check made payable to Shelley Maier in the gross amount of \$24,221.60, less all applicable withholdings and deductions.
- b. PPB will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
